

ORDINANCE NO. 1720

AN ORDINANCE TO AMEND TITLE IX, CHAPTER 14, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING SECTION 12 THEREOF TO PROVIDE FOR AMENDMENTS TO THE MAJOR STREET PLAN BY ORDINANCE; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES ORDAIN AS FOLLOWS:

SECTION 1. Title IX, Chapter 14, Section 12, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:



AMENDMENTS: The Major Street Plan may be amended by an addition thereto or a deletion therefrom and/or changes in the rights-of-way widths and/or changes in the alignments by [a resolution] an ordinance duly adopted by the Board of Commissioners. Said amendment, or change, must first be referred to the Planning Commission for a recommendation.


SECTION 2. All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 3. If any section, paragraph, sentence, phrase, term, word, or connotation of this ordinance, or portion thereof, is for any reason held invalid, inapplicable, or unconstitutional by any Court of competent jurisdiction, such holding shall not invalidate the remaining portions of this ordinance.




