12 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
13 AS FOLLOWS:

14 SECTION 1: The corporate limits of the City of Las Vegas, Nevada, are hereby
15 extended to include, annex to, and make a part of the City of Las Vegas, Nevada, the following
16 described real property, to-wit:

17 That portion of Township 19 South, Range 60 East, M.D.M., in the County Clark,
18 State of Nevada described as:

19 PARCEL NUMBER 308 as shown on the Record of Survey on file in File 52 of
20 Surveys, Page 70 of Clark County, Nevada Records.

21 SECTION 2: That said City Council has determined and does hereby determine, that
22 said described territory meets the requirements provided by law for annexation to the City of Las
23 Vegas for the following reasons:

- 24 A. The area to be annexed was contiguous to the City's boundaries at the time the
25 annexation proceedings were instituted;
- 26 B. More than one-eighth (1/8) of the aggregate external boundaries of the area are
27 contiguous to the City of Las Vegas;
- 28 C. The territory proposed to be annexed is not included within the boundaries of

1 another incorporated city or within the boundaries of any unincorporated town
2 as those boundaries existed as of July 1, 1983;

3 D. The City of Las Vegas is eligible to annex the area described in this report
4 since the landowners have signed a petition constituting one hundred percent
5 (100%) of the owners of record of individual lots or parcels of land within the
6 annexation area.

7 SECTION 3: The City of Las Vegas will provide police protection through the Las
8 Vegas Metropolitan Police Department, fire protection, street maintenance, and library services
9 immediately upon annexation. Garbage collection by the company franchised by the City will also
10 be provided immediately. The City sanitary sewer system will serve the proposed annexation area.
11 Any connection to or extension of this sewer line to serve the annexation area shall be at the expense
12 of the landowners. Other services, such as participation in the City's recreational programs, special
13 education classes and programs, public works planning, building inspections, and other City Hall
14 services will also be available immediately. Utilities such as gas, electricity, telephone, and water are
15 provided by private utility companies and other services to the area will not be affected by annexation.
16 Street paving, curbs and gutters, sidewalks and street lights which are not in place at the time of
17 annexation will be installed in the presently developed areas upon the request of the property owners
18 and at their expense by means of special assessment districts. Such improvements will be extended
19 into the undeveloped areas as development takes place and the need therefor arises, and will be located
20 according to the needs of the area at that time. Such installations will also be made at the expense of
21 the property owners, either by means of special assessment districts or as prerequisites to the approval
22 of subdivision plats or the issuance of building permits, rezonings, zone variances or special use
23 permits.

24 SECTION 4: The annexation of said described territory shall become effective on the
25 13th day of December, 1996, and on such date the City of Las Vegas will have the funds appropriated
26 in sufficient amount to finance the extension into said described territory of police protection, fire
27 protection, street maintenance, street sweeping, and street lighting maintenance.

28 SECTION 5: Said described territory, together with the inhabitants and property

1 thereof, shall, from and after the 13th day of December, 1996, be subject to all debts, laws, ordinances
2 and regulations in force in the City of Las Vegas and shall be entitled to the same privileges and
3 benefits as other parts of said City, and shall be subject to municipal taxes levied by the City of Las
4 Vegas, Nevada.

5 SECTION 6: The City Engineer of the City of Las Vegas, Nevada, is hereby instructed
6 to cause to be prepared an accurate map or plat of said described territory and to record the same,
7 together with a certified copy of this ordinance in the office of the County Recorder of Clark County,
8 Nevada, which said recording shall be done prior to the 13th day of December, 1996.

9 SECTION 7: The said described territory, which heretofore has been zoned R-E
10 (County of Clark classification), is hereby classified as N-U (City of Las Vegas classification), which
11 is deemed to be the City equivalent of said County classification.

12 SECTION 8: If any section, subsection, subdivision, paragraph, sentence, clause or
13 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
14 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
15 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
16 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
17 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
18 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
19 invalid or ineffective.

20 SECTION 9: All ordinances or parts of ordinances, sections, subsections, phrases,
21 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
