ORDINANCE NO. 5639

AN ORDINANCE TO CORRECT THE MAPS THAT DEPICT THE BOUNDARIES OF THE DOWNTOWN AREA AS DESCRIBED IN THE DOWNTOWN LAS VEGAS CENTENNIAL PLAN, THE LAS VEGAS 2020 MASTER PLAN, AND THE DOWNTOWN OVERLAY DISTRICT, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Makes minor corrections to the maps that depict the boundaries of the downtown area as described in the Downtown Las Vegas Centennial Plan, the Las Vegas 2020 Master Plan, and the Downtown Overlay District.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: A number of maps that were adopted as part of the City's Downtown Las Vegas Centennial Plan, Las Vegas 2020 Master Plan, and Downtown Overlay District vary slightly from the descriptions of the boundaries that were approved for those areas and that were intended to be reflected in the maps. In order to conform the maps to the boundaries intended, it is the intent of the City Council to amend the various maps as set forth in Sections 2 to 5, inclusive, of this Ordinance.

SECTION 2: The Downtown Las Vegas Centennial Plan, as adopted by Ordinance No. 5238, is hereby amended by amending Maps 5 and 6 thereof to reflect the boundary corrections described in the map attached as Exhibit 1.

SECTION 3: The Las Vegas 2020 Master Plan, as adopted by Ordinance No. 5250, is hereby amended by amending Maps 7 and 8 thereof to reflect the boundary corrections described in the map attached as Exhibit 1.

SECTION 4: Title 19, Chapter 6, Section 60, of the Municipal Code of the City of Las Vegas, 1983 Edition, is hereby amended by amending the map that is contained in that Section to reflect the boundary corrections described in the map attached as Exhibit 1.

SECTION 5: The Planning and Development Department is authorized and directed to:

(A) Prepare amended maps to correspond to the formats of the various maps

1 referred to in Sections 2 and 3 of this Ordinance, and to include them or attach them to the appropriate
2 Plan documents; and

3 (B) Prepare an amended map to correspond to the format of the map described in
4 Section 4 of this Ordinance for subsequent inclusion in the Municipal Code.

5 SECTION 6: If any section, subsection, subdivision, paragraph, sentence, clause or
6 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
7 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
8 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
9 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
10 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
11 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
12 invalid or ineffective.

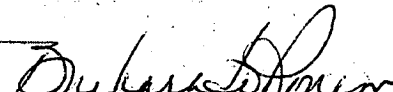
13 SECTION 7: All ordinances or parts of ordinances or sections, subsections, phrases,

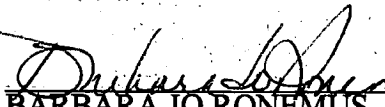

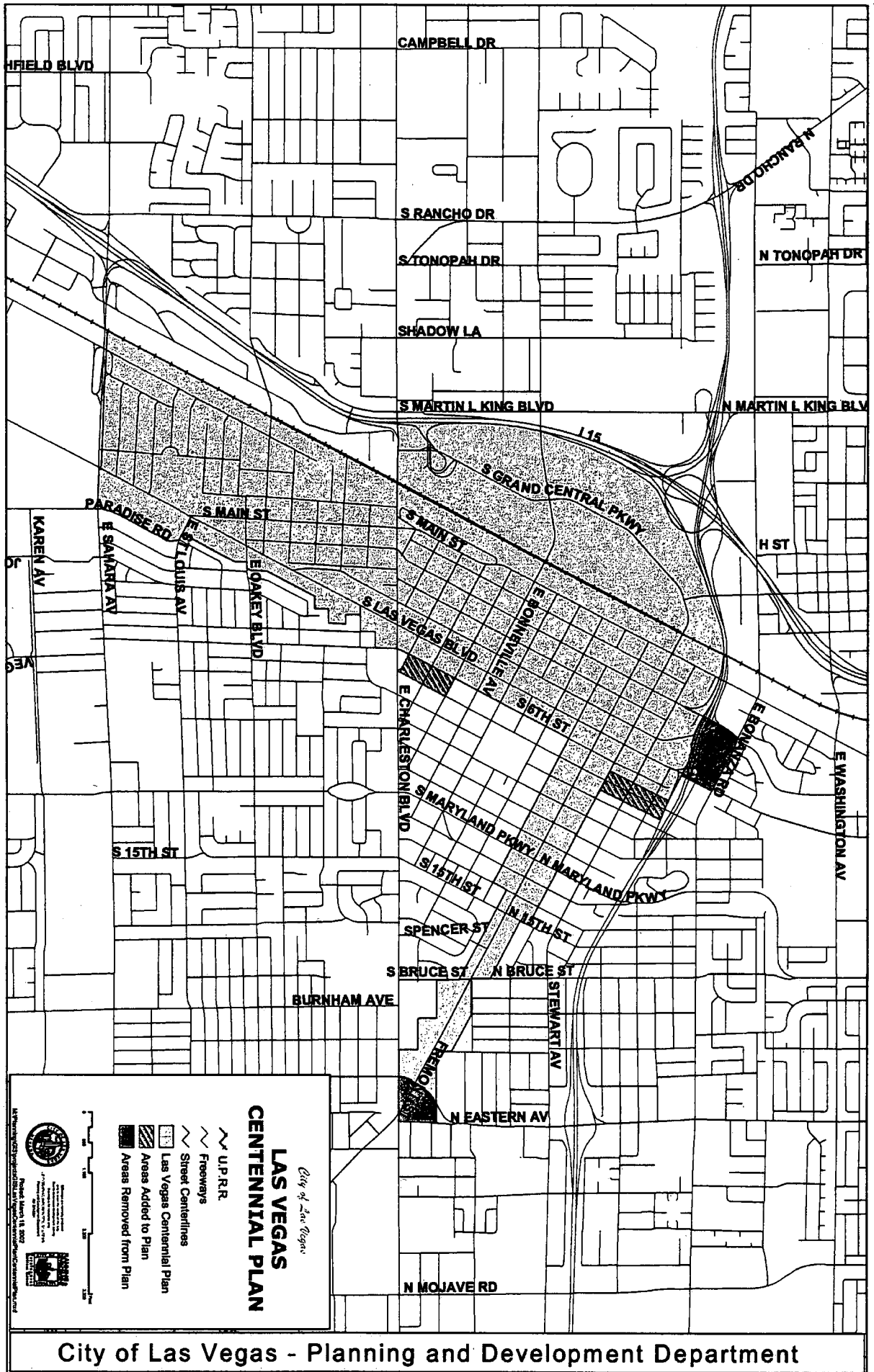

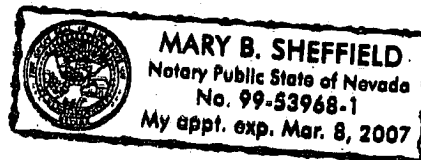
