10 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES ORDAIN AS
11 FOLLOWS:

12 SECTION 1: Title 2, Chapter 44, Section 10 of the Municipal Code of the City
13 of Las Vegas, Nevada, 1983 Edition, is hereby amended as follows:

14 **2.44.010 Established -- Composition -- Compensation -- Qualifications.**

15 (A) There is created the City Planning Commission to consist of seven members
16 appointed by the Mayor with the approval of the governing body.

17 (B) Each member of the Planning Commission shall receive from the City, as
18 and for compensation for his or her services thereon, the sum of fifty dollars for each meeting
19 of the Commission that he or she actually attends.

20 [(C) All members of the Commission shall hold no other public office, except
21 that one such member may be a member of the Zoning Board of Adjustment.]

22 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause
23 or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or
24 invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
25 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
26 Council of the City of Las Vegas hereby declares that it would have passed each section,

1 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
2 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
3 declared unconstitutional, invalid or ineffective.

4 SECTION 3: All ordinances or parts of ordinances, sections, subsections,
5 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las
6 Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.






