11 ORDAIN AS FOLLOWS:

12 SECTION 1: Title 6, Chapter 20, Section 100, of the Municipal Code of
13 the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

14 **6.20.100.** The business license fee for each cable communications company shall be based
15 upon its gross revenues, [as defined in LVMC 6.20.010(B)(26) shall be] in the
16 amount as set out in LVMC [6.04.050] 6.04.005.

17 SECTION 2: If any section, subsection, subdivision, paragraph, sentence,
18 clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional
19 or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
20 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
21 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
22 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
23 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
24 declared unconstitutional, invalid or ineffective.

25 SECTION 3: All ordinances or parts of ordinances, sections, subsections,
26 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las

Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.
