10 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
11 ORDAIN AS FOLLOWS:

12 SECTION 1: Title 6, Chapter 4, Section 100, of the Municipal Code of the
13 City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

14 **6.04.100:** The license fee is five hundred dollars semiannually for each main banking
15 facility of each bank [as that term is defined in NRS 657.016], commercial
16 bank and banking corporation and for each branch facility thereof. "Bank,"
17 "commercial bank" and "banking corporation" refer to corporations,
18 whether chartered by the State or Federal government, conducting the
19 business of receiving money as demand deposits or otherwise carrying on
20 a banking and trust business.


21 SECTION 2: If any section, subsection, subdivision, paragraph, sentence,
22 clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional
23 or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
24 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
25 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
26 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that

1 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
2 declared unconstitutional, invalid or ineffective.

3 SECTION 3: All ordinances or parts of ordinances, sections, subsections,
4 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las
5 Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.




