14 THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA DOES
15 HEREBY ORDAIN AS FOLLOWS:

16 SECTION 1: Title 2, Chapter 26, Section 30, of the
17 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
18 hereby amended to read as follows:

19 2.26.030:(A) Except as is otherwise provided in Subsections (B)
20 and (C) of this Section[, the salaries of the] and
21 LVMC §2.26.035, the salary of each Municipal Court
22 [Judges] Judge shall each be [thirty-seven] forty-
23 seven thousand five hundred dollars per year.

24 (B) [The salaries of the Municipal Court Judges of
25 Departments 2 and 3 shall each be forty-seven
26 thousand five hundred dollars per year beginning
27 with the term of office following the primary and
28 general elections of May and June, 1985.

29 (C)] The salaries of the Municipal Court Judges of
30 Departments 1 and 4 shall each be [forty-seven]
31 fifty-five thousand [five hundred] dollars per year
32 beginning with the term of office following the

1 primary and general electons [of] that will be held
2 in May and June[,] of 1987.

3 (C) The salaries of the Municipal Court Judges of
4 Departments 2 and 3 shall each be fifty-five
5 thousand dollars per year beginning with the term
6 of office following the primary and general elec-
7 tions that will be held in May and June of 1989.

8 SECTION 2: Title 2, Chapter 26, of the Municipal Code
9 of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended
10 by adding thereto a new section, to be designated as Section 35,
11 reading as follows:

12 2.26.035:(A) The salaries of the Municipal Court Judges that are
13 provided for in subsection (B) of LVMC §2.26.030
14 shall automatically be increased:

15 (1) On the first day of July, 1988, in the same
16 proportion that the index figure of the
17 National Consumer Price Index for All Urban
18 Consumers for All Items, U.S. City Average
19 (1967 = 100) that is published by the Bureau
20 of Labor Statistics, United States Department
21 of Labor, for March of 1988 has increased
22 above such index figure for March of 1987; and

23 (2) On the first day of July in each year there-
24 after in the same proportion that such index
25 figure for March of that year has increased
26 above such index figure for March of the
27 previous year.

28 (B) The salaries of the Municipal Court Judges that are
29 provided for in subsection (C) of LVMC §2.26.030
30 shall automatically be increased:

31 (1) On the first day of July, 1989, in an amount
32 that is equal to the increase that is provided

1 for in paragraph (1) of subsection (A) of this
2 Section and then further increased in the same
3 proportion that the index figure of the
4 National Consumer Price Index for All Urban
5 Consumers for All Items, U.S. City Average
6 (1967 = 100) that is published by the Bureau
7 of Labor Statistics, United States Department
8 of Labor, for March of 1989 has increased
9 above such index figure for March of 1988; and

10 (2) On the first day of July in each year
11 thereafter, in the same proportion that such
12 index figure for March of that year has
13 increased above such index figure for March
14 of the previous year.

15 SECTION 3: Title 2, Chapter 2, Section 75, of the
16 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
17 hereby amended to read as follows:

18 2.02.075: (A) The salaries of the members of the City Council
19 that are provided for in subsection (B) of LVMC
20 §2.02.070 shall automatically be increased:

21 (1) On the first day of July, 1988, in the same
22 proportion that the index figure of the
23 National Consumer Price Index for All Urban
24 Consumers for All Items, U.S. City Average
25 (1967 = 100) that is published by the Bureau
26 of Labor Statistics, United States Department
27 of Labor, for March of 1988[,] has increased
28 above such index figure for March of 1987; and

29 (2) On the first day of July in each year
30 thereafter, in the same proportion that such
31 index figure for March of that year has
32 increased above such index figure for [April]

1 March of the previous year.

2 (B) The salaries of the members of the City Council
3 that are provided for in subsection (C) of LVMC
4 §2.02.070 shall automatically be increased:

5 (1) On the first day of July, 1989, in an amount
6 that is equal to the increase that is provided
7 for in paragraph (1) of subsection (A) of this
8 Section and then further increased in the same
9 proportion that the index figure of the
10 National Consumer Price Index for All Urban
11 Consumers for All Items, U.S. City Average
12 (1967 = 100) that is published by the Bureau
13 of Labor Statistics, United States Department
14 of Labor, for March of 1989 has increased
15 above such index figure for March of 1988; and

16 (2) On the first day of July in each year
17 thereafter, in the same proportion that such
18 index figure for March of that year has
19 increased above such index figure for March of
20 the previous year.

21 SECTION 4: If any section, subsection, subdivision
22 paragraph, sentence, clause or phrase in this ordinance or any
23 part thereof, is for any reason held to be unconstitutional or
24 invalid or ineffective by any court of competent jurisdiction,
25 such decision shall not affect the validity or effectiveness of
26 the remaining portions of this ordinance or any part thereof.
27 The City Council of the City of Las Vegas, Nevada, hereby
28 declares that it would have passed each section, subsection, sub-
29 division, paragraph, sentence, clause or phrase thereof,
30 irrespective of the fact that any one or more sections, subsec-
31 tions, subdivisions, paragraphs, sentences, clauses or phrases be
32 declared unconstitutional, invalid or ineffective.
