13 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
14 ORDAIN AS FOLLOWS:

15 SECTION 1: The Master Plan of Streets and Highways pro-
16 vided for in Title 13, Chapter 12, Section 30, of the Municipal
17 Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby
18 amended by deleting therefrom:

19 Bonneville Avenue between Las Vegas Boulevard South and
20 Maryland Parkway.

21 SECTION 2: If any section, subsection, subdivision
22 paragraph, sentence, clause or phrase in this ordinance or any
23 part thereof, is for any reason held to be unconstitutional or
24 invalid or ineffective by any court of competent jurisdiction,
25 such decision shall not affect the validity or effectiveness of
26 the remaining portions of this ordinance or any part thereof.
27 The City Council of the City of Las Vegas, Nevada, hereby
28 declares that it would have passed each section, subsection, sub-
29 division, paragraph, sentence, clause or phrase thereof,
30 irrespective of the fact that any one or more sections, subsec-
31 tions, subdivisions, paragraphs, sentences, clauses or phrases be
32 declared unconstitutional, invalid or ineffective.

SECTION 3: All ordinances or parts of ordinances, sec-
tions, subsections, phrases, sentences, clauses or paragraphs

1 contained in the Municipal Code of the City of Las Vegas, Nevada,
2 1983 Edition, in conflict herewith are hereby repealed.


