AN ORDINANCE RELATING TO THE USE OF STREETS AND SIDEWALKS; AMENDING TITLE 11, CHAPTER 22, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, BY ADDING THERETO TWO NEW SECTIONS THAT DEFINE CERTAIN TERMS AND PROVIDE REGULATIONS CONCERNING THE USE OF COASTERS, ROLLER SKATES, SCOOTERS AND SKATEBOARDS ON CERTAIN PRIVATE PROPERTY; AMENDING SECTION 130 OF SAID TITLE AND CHAPTER TO PROHIBIT THE USE OF COASTERS, ROLLER SKATES, SCOOTERS AND SKATEBOARDS ON PUBLIC PROPERTY ON WHICH SIGNS HAVE BEEN ERECTED GIVING NOTICE OF SUCH PROHIBITION; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; and REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Prohibits the use of skateboards in certain public and private places within the City

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 11, Chapter 22, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto the provisions that are set forth as Sections 2 and 3 of this Ordinance.

SECTION 2: As used in this Chapter, unless the context otherwise requires, the following terms shall have the meanings that are ascribed to them as follows:

(A) "Coaster" means a non-motorized wheeled vehicle which, after being propelled by either human or mechanical force of any kind, becomes by momentum or gravity a free-moving vehicle without the need of further application of propulsive power and includes a child's wagon.

(B) "Roller skate" means tandem sets of wheels mounted on a metal frame that can be fitted to the sole of a shoe or a shoe mounted on tandem sets of wheels and used for skating over flat surfaces.

1 (C) "Scooter" means a foot-propelled vehicle consisting
2 of a platform of metal, plastic, wood or other type
3 of composition or combinations thereof mounted on
4 or between one set or tandem sets of wheels with an
5 upright steering handle attached to the front of
6 the platform or the front wheel or wheels.

7 (D) "Skateboard" means a foot-propelled vehicle con-
8 sisting of a platform of metal, plastic, wood or
9 other type of composition or combinations thereof
10 mounted on tandem sets of wheels.

11 SECTION 3: Any person who shall ride or use a coaster,
12 roller skates, scooter, skateboard, toy vehicle or similar device
13 on any private property to which the public is invited after
14 signs have been erected at the entrances to, or displayed promi-
15 nently on, the property prohibiting the use of coasters, roller
16 skates, scooters, skateboards, toy vehicles or similar devices
17 shall be deemed to have committed a trespass.

18 SECTION 4: Title 11, Chapter 22, Section 130, of the
19 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
20 hereby amended to read as follows:

21 11.22.130 [(A)] It shall be unlawful to any person to ride or
22 use [roller skates, coasters, skateboards, scooters,] a
23 coaster, roller skates, scooter, skateboard, toy
24 [vehicles] vehicle or similar [device on] device:

25 (A) On any roadway except while crossing a street [on]
26 at a crosswalk, and, when any such device is so
27 crossing, it shall be granted all of the rights and
28 shall be subject to all of the duties applicable to
29 pedestrians[.];

30 (B) [It shall be unlawful for any persons to ride or
31 use any of the devices prescribed in Subsection
32 (A) of this Section on] On the sidewalks of Fremont

1 Street between Main Street and Seventh Street
2 which, because of the high volume of pedestrian
3 traffic normally present[. This area], shall be
4 posted with signs indicating that the use of these
5 devices on the sidewalk is prohibited[.];

6 (C) On any other public property when signs have been
7 erected at the entrances to, or displayed promi-
8 nently on, the property prohibiting the use of
9 coasters, roller skates, scooters, skateboards, toy
10 vehicles or similar devices on such property; or

11 (D) In any other place in the City in such a manner as
12 to be dangerous to persons or property.

13 SECTION 5: If any section, subsection, subdivision
14 paragraph, sentence, clause or phrase in this ordinance or any
15 part thereof, is for any reason held to be unconstitutional or
16 invalid or ineffective by any court of competent jurisdiction,
17 such decision shall not affect the validity or effectiveness of
18 the remaining portions of this ordinance or any part thereof.
19 The City Council of the City of Las Vegas, Nevada, hereby
20 declares that it would have passed each section, subsection, sub-
21 division, paragraph, sentence, clause or phrase thereof,
22 irrespective of the fact that any one or more sections, subsec-
23 tions, subdivisions, paragraphs, sentences, clauses or phrases be
24 declared unconstitutional, invalid or ineffective.


25 SECTION 6: Whenever in this ordinance any act is prohi-
26 bited or is made or declared to be unlawful or an offense or a
27 misdemeanor, or whenever in this ordinance the doing of any act
28 is required or the failure to do any act is made or declared to
29 be unlawful or an offense or a misdemeanor, the doing of any such
30 prohibited act or the failure to do any such required act shall
31 constitute a misdemeanor and upon conviction thereof, shall be
32 punished by a fine of not more than \$1,000.00 or by imprisonment

1 for a term of not more than six months, or by any combination of
2 such fine and imprisonment. Any day of any violation of this
3 ordinance shall constitute a separate offense.


4 SECTION 7: All ordinances or parts of ordinances, sec-

7 1983 Edition, in conflict herewith are hereby repealed.




