12 THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA DOES
13 HEREBY ORDAIN AS FOLLOWS:

14 SECTION 1: The Master Plan of Streets and Highways
15 provided for in Title 13, Chapter 12, Section 30 of the Municipal
16 Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby
17 amended as follows:

18 Torrey Pines Drive, at its intersection with Rancho Drive, is
19 realigned and the realignment is reduced in width from 80
20 feet to 60 feet, all in accordance with Engineering Drawing
21 No. 115-386.

22 SECTION 2: The Master Plan of Streets and Highways
23 provided for in Title 13, Chapter 12, Section 30 of the Municipal
24 Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby
25 amended as follows:

26 Engineering Drawing No. 115-386, on file in the Department of
27 Public Works, is hereby adopted.

28 SECTION 3: If any section, subsection, subdivision,
29 paragraph, sentence, clause or phrase in this ordinance or any
30 part thereof, is for any reason held to be unconstitutional or
31 invalid or ineffective by any court of competent jurisdiction,
32 such decision shall not affect the validity or effectiveness of

1 the remaining portions of this ordinance or any part thereof.
2 The City Council of the City of Las Vegas, Nevada, hereby
3 declares that it would have passed each section, subsection, sub-
4 division, paragraph, sentence, clause or phrase thereof irrespec-
5 tive of the fact that any one or more sections, subsections, sub-
6 divisions, paragraphs, sentences, clauses or phrases be declared
7 unconstitutional, invalid or ineffective.

8 SECTION 4: All ordinances or parts of ordinances,
9 sections, subsections, phrases, sentences, clauses or paragraphs
10 contained in the Municipal Code of the City of Las Vegas, Nevada,
11 1983 Edition, in conflict herewith are hereby repealed.



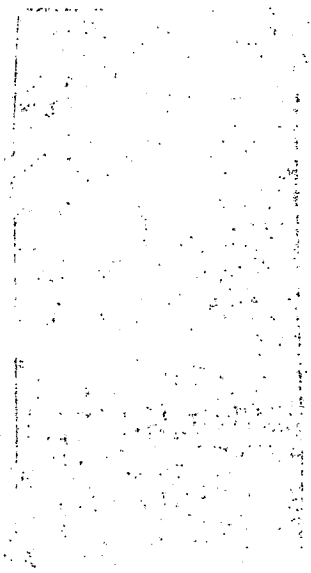
