

ORDINANCE NO. 978

1 AN ORDINANCE OF THE CITY OF LAS VEGAS, COUNTY OF CLARK, STATE
2 OF NEVADA, ESTABLISHING A RECREATION ADVISORY COMMISSION AND
MAKING DEFINITE THE ORGANIZATIONS POWERS AND DUTIES.

3 THE CITY COMMISSION OF THE CITY OF LAS VEGAS DOES
4 ORDAIN AS FOLLOWS:

5 SECTION 1. There is hereby created a Recreation
6 Advisory Commission consisting of five members.

7 The Recreation Advisory Commission members shall be
8 appointed as follows:

9 A. Five members shall be appointed by the City Commission.

10 B. Members of the Commission shall serve for a period of
11 three years.

12 C. The first Commission to be appointed shall at the
13 first meeting so classify its members by lot that
14 two shall serve for one year; two shall serve for
15 two years; and one shall serve for three years.

16 D. At the expiration of each of the terms so provided
17 for, a successor shall be appointed by the City
18 Commission for a term of three years.

19 E. Vacancies in said Commission occurring by something
20 other than expiration of term, shall be filled by
21 appointment by the Board of City Commissioners for
22 the remainder of the term.

23 SECTION 2. The officers of the Commission shall be
24 a Chairman, a Vice-Chairman and a Secretary. Within fifteen
25 days after the appointment of the Commission, the members thereof
26 shall meet in regular session and select from their members the
27 Chairman and the Vice-Chairman. The Secretary shall be the
28 Superintendent of Recreation of the City of Las Vegas. The
29 duties of the officers of the Commission shall respectively be
30 such as are usually carried by such officers. The officers
31 shall hold office for one year, or until their successors are
32 selected.

1 The Commission shall adopt rules and regulations to
2 govern procedures and shall, by vote, set a time for regular
3 meetings which shall be held at least once a month, and shall
4 determine the manner in which special meetings may be called,
5 held and the notice given. A majority of the regular members
6 shall constitute a quorum for all purposes. Absence from two
7 consecutive regular meetings without formal consent of the
8 Recreation Advisory Commission shall constitute sufficient
9 grounds for the Board of City Commissioners, at its discretion,
10 to remove said member and declare the position vacant. Minutes
11 of meetings of the Commission shall be filed with the City Clerk
12 within ten days following such meeting.

13 SECTION 3. The duties of the Recreation Commission
14 shall be:

- 15 A. To act in an advisory capacity, in cooperation with
16 the Superintendent of Recreation, to the Board of
17 City Commissioners on all matters pertaining to public
18 recreation and to cooperate with other Governmental
19 agencies and civic groups in the advancement of sound
20 recreation planning.
- 21 B. To aid in defining areas of responsibility of the City
22 of Las Vegas, Clark County Fair and Recreation Board,
23 Clark County, and the Clark County School District.
- 24 C. To aid in coordinating the recreation services with
25 the program of other Governmental agencies and other
26 voluntary organizations.
- 27 D. To assist in the functions of the Recreation Depart-
28 ment with the public.

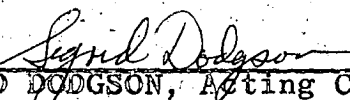

30 SECTION 4. The Superintendent of Recreation or his
31 representative shall attend all meetings of the Commission and

16 Whipple and Mayor Gragson.

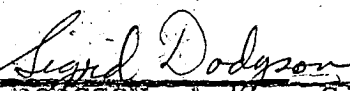
