

ORDINANCE NO. 989

1 AN ORDINANCE TO AMEND TITLE X, CHAPTER 17, SECTION 26, SCHEDULE IX,
2 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY
3 PROVIDING FOR NO STOPPING, STANDING OR PARKING DURING CERTAIN HOURS
4 ON CERTAIN STREETS; PROVIDING FOR OTHER MATTERS PROPERLY RELATED
THERETO; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; AND REPEAL-
ING ALL ORDINANCES, CHAPTERS, SECTIONS OR PORTIONS OF ORDINANCES
IN CONFLICT HEREWITH.

5 THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DO
6 ORDAIN AS FOLLOWS:

7 SECTION 1. Schedule IX, as adopted by reference and incor-
8 porated into Title X, Chapter 17, Section 26 of the Municipal Code
9 of the City of Las Vegas, Nevada, 1960, is hereby amended by add-
10 ing the following restrictions on stopping, standing or parking
11 during certain hours on certain streets:

12 Fremont Street - all of the south side of Fremont
13 Street between 2nd and 7th Streets, and the north
14 side between 3rd and 7th Streets. (No parking
15 from 4:00 A.M. to 5:30 A.M.)

16 Carson - along both sides of Carson from Main to
17 7th Street. (No parking from 4:00 A.M. to 5:30 A.M.)

18 Ogden - along both sides of Ogden from Main Street
19 to 7th Street. (No parking from 4:00 A.M. to 5:30 A.M.)
20 1st, 2nd, 3rd, 4th, 5th, 6th and 7th Streets -
21 along both sides of 1st through 7th Street between
22 Carson and Ogden. (No parking from 4:00 A.M. to
23 5:30 A.M.)

24 SECTION 2. Any person, firm or corporation violating any
25 of the provisions of this ordinance shall, upon conviction thereof,
26 be punished by a fine of not less than \$25.00 nor more than
27 \$500.00 and/or imprisonment in the City Jail for not more than six
28 months, or by any combination of such fine and imprisonment.
29 Every day of such violation shall be a separate offense.

30 SECTION 3. All ordinances or parts of ordinances, chap-
31 ters, sections, subsections, phrases, sentences, clauses or para-
32 graphs contained in the Municipal Code of the City of Las Vegas,

1 Nevada, 1960, in conflict herewith are hereby repealed.

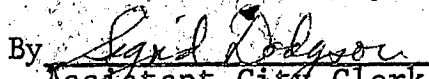

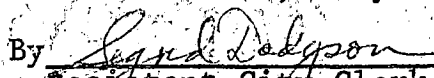
