

AN ORDINANCE ANNEXING TO, AND MAKING A PART OF THE CITY OF LAS VEGAS, CERTAIN SPECIFICALLY DESCRIBED TERRITORY ADJOINING AND CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF LAS VEGAS; DECLARING SAID TERRITORY AND INHABITANTS TO BE ANNEXED THERETO AND SUBJECT TO ALL LAWS AND ORDINANCES; ORDERING A PLAT SHOWING SAID TERRITORY TO BE RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF THE COUNTY OF CLARK, STATE OF NEVADA; AND PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. Pursuant to a Petition duly presented to the Board of Commissioners of the City of Las Vegas, signed by a majority of the freeholders in the area containing the hereinafter described real property requesting the Board of Commissioners of the City of Las Vegas to annex to and make a part of the City of Las Vegas, the hereinafter described real property, the exterior boundaries of the City of Las Vegas are hereby extended to annex to, and include therein, the following described real property, to-wit:

That portion of the Northeast Quarter (NE $\frac{1}{4}$) of Section 8, Township 21 South, Range 61 East, M.D.B.&M., Clark County, Nevada, more particularly described as follows:

COMMENCING at the Northeast corner of said Section 8, said point being the true point of beginning, thence North 89° 26' 29" West along the north line of said Section a distance of 2609.32 feet to a point; said point being the North 1/4 corner of said section, thence South 03° 51' 05" East along the west line of the said Northeast Quarter (NE $\frac{1}{4}$) of Section 8 a distance of 2610.93 feet to a point, said point being the center of said Section 8, thence South 88° 53' 16" East along the south line of the said Northeast Quarter (NE $\frac{1}{4}$) of Section 8 a distance of 1037.25 feet to a point on the west right-of-way line of the proposed freeway, thence North 35° 31' 49" East along the west right-of-way line of said freeway a distance of 2395.26 feet to a point on the east line of said Section 8, thence North 0° 25' 21" East along the east line of said Section 8, a distance of 650.46 feet to a point, said point being the true point of beginning.

The area of said parcel is 119.52 acres more or less.

TOGETHER with the tenements, property and inhabitants within said parcel of real property is hereby declared to be a part of the City of Las Vegas.

SECTION 2. Said parcel of real property, together with the tenements and inhabitants thereof, shall be subject to all of the laws applicable to the City of Las Vegas.

SECTION 3. The City Engineer of the City of Las Vegas is hereby instructed to prepare a plat of said territory described in Section 1 of this Ordinance and to file the same for record in the Office of the County Recorder of Clark County, Nevada.

SECTION 4. This Ordinance shall be in full force and effect upon its final passage and publication as in the next section provided.

Said Territorial and Hab-

AND SUBJECT TO ALL LAWS AND

feet to a point on the east line of
said Section 8, thence North 01° 25'
21" East along the east line of
said Section 8, a distance of 650.46
feet to a point, said point being the
true point of beginning,
