

AN ORDINANCE TO AMEND SUBSECTION 13A OF SECTION 3 OF ORDINANCE NO. 760, BY INCREASING THE NUMBER OF HOTEL ROOMS REQUIRED FOR SERVICE BAR, TAVERN OR COCKTAIL LOUNGE FROM 50 ROOMS TO 100 ROOMS; PROVIDING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. Subsection 13A of Section 3 of Ordinance No. 760 is hereby amended to read as follows:

Restaurant, cabaret, tavern, cocktail lounge, or service bar wherein the sale, serving or dispensing of beverages, and alcoholic liquors as defined and regulated by Chapter 16, Code of Las Vegas, Nevada, 1949, as amended, may be permitted provided, however, that service bars in restaurants shall not be permitted unless there shall be a seating capacity of more than one hundred (100) persons at one time; and provided further that a service bar, tavern or cocktail lounge may be permitted in a hotel having more than 100 guest rooms, provided that all other requirements of law regulating and permitting such uses are first complied with.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. Any person who violates any provision of this ordinance shall be guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not more than \$500.00, or by imprisonment in the City Jail for not more than six months, or by both such fine and imprisonment.

SECTION 4. This ordinance shall be in full force and effect upon its reading and adoption and publication as in the next section provided.

SECTION 5. The City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas shall cause this ordinance to be published once a week for two successive weeks immediately following its adoption, in the Las Vegas Morning Sun, a daily newspaper published in the City of Las Vegas, Nevada, and it shall become effective upon its second publication.
