

AN ORDINANCE TO AMEND TITLE II, CHAPTER 7, SECTION 5 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960; BY CHANGING THE NUMBER OF MEMBERS ON SOLICITATIONS REVIEW BOARD FROM 6 TO 5 MEMBERS; PROVIDING FOR METHOD OF APPOINTMENT, TERM OF OFFICE AND FILLING OF VACANCIES THEREON; PROVIDING OTHER MATTERS PROPERLY RELATED THERETO AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. Section 5 of Chapter 7, Title II, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

SOLICITATIONS REVIEW BOARD. A Solicitations Review Board, composed of five (5) members, shall be appointed by the Board of Commissioners of the City of Las Vegas, and such Board is hereby created. The members of such Board shall hold office for a period of two (2) years. Those persons already members of said Board shall continue to serve out the term of their appointment. The person appointed by virtue of the provisions of this Chapter shall have a two (2) year appointment. Appointments shall be made so that as near as possible the terms shall be staggered. Vacancies on the said Board shall be filled by appointment made by the Board of Commissioners.

SECTION 2. All ordinances or parts of ordinances, chapters, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.
