

ORDINANCE NO. 795

AN ORDINANCE TO AMEND SECTION IV OF ORDINANCE NO. 378, REFERRED TO AS SECTION 10, CHAPTER 24, CODE OF LAS VEGAS, NEVADA, 1949, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF THE SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. The Land Use Plan Map adopted by Section IV of Ordinance No. 378, also referred to as Section 10, Chapter 24, Code of the City of Las Vegas, 1949, is hereby amended to read as follows:

From R-E to R-1: (Z-8-59)

Northeast Quarter (NE $\frac{1}{4}$) of Section 25, T20S, R60E, M.D.B. & M., bounded by Decatur, Vegas Drive, Washington Avenue and the City Limits, Las Vegas, Nevada.

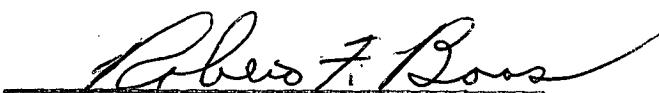
SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

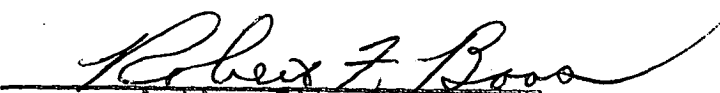
