

ORDINANCE NO. 791

AN ORDINANCE TO AMEND SUBSECTION 7 OF SECTION 1 OF ORDINANCE NO. 631 BEING AN ORDINANCE DEFINING THE OFFENSE OF VAGRANCY; PROVIDING PUNISHMENT UPON CONVICTION THEREFORE; PROVIDING OTHER MATTERS RELATED THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. Subsection 7 of Section 1 of Ordinance No. 631 is hereby amended to read as follows:

7. Every common prostitute; or every female who agrees to have an act of sexual intercourse for hire with a person who is not her husband; or

SECTION 2. Any violation of this ordinance, or any provision herein contained shall constitute a misdemeanor, and upon conviction thereof shall be punished by a fine of not to exceed Five Hundred (\$500) Dollars, and/or six months in the City Jail, or a combination of both.

SECTION 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. The Acting City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas shall cause this ordinance to be published once a week for two successive weeks immediately following its first reading and adoption in the Las Vegas Morning Sun, a daily newspaper published in the City of Las Vegas.
