

ORDINANCE NO. 790

AN ORDINANCE TO AMEND SECTION 4, OF ORDINANCE NO. 750, BY ADDING A NEW SUBSECTION TO BE DESIGNATED SUBSECTION A. 7., DEALING WITH THE REGULATING AND CONTROLLING OF TRAFFIC BY DESIGNATING A CERTAIN PORTION OF AN ALLEY WHERE TRAFFIC SHALL MOVE ONLY IN ONE DIRECTION; PROVIDING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. Section 4, of Ordinance 750, which amended Section 1, of Ordinance 569, is hereby further amended by adding a new subsection to read as follows:

A.	<u>Name of Street</u>	<u>Direction of Traffic Movement</u>
7.	The north-south portion of the alley in the block between 4th, 5th, Fremont and Carson Streets	South

SECTION 2. Any person violating the provisions of this ordinance shall be guilty of a misdemeanor, and on conviction thereof shall be punished by a fine of not more than Five Hundred Dollars (\$500.00), and/or six (6) months in the City Jail, or by a combination of both such fine and imprisonment.

SECTION 3. All ordinances or parts of this ordinance in conflict herewith are hereby repealed.

SECTION 4. The Acting City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas shall cause this ordinance to be published once a week for two successive weeks immediately followings its first reading and adoption in the Las Vegas Morning Sun, a daily newspaper published in the City of Las Vegas.
