

AN ORDINANCE TO AMEND SECTION IV OF ORDINANCE NO. 378, REFERRED TO AS SECTION 10, CHAPTER 24, CODE OF LAS VEGAS, NEVADA, 1949, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF THE SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. The Land Use Plan Map adopted by Section IV of Ordinance No. 378, also referred to as Section 10, Chapter 24, Code of the City of Las Vegas, 1949, is hereby amended to read as follows:

(a) From R-4 to C-1: (Z-13-58)

Lots 9 through 16, Block 8, Boulder Addition.

(b) From R-2 to C-1: (Z-15-58)

Lots 1 through 8, Block 4, Biltmore Addition, limited, however, as provided in Chapter 24, Section 20, Code of Las Vegas, Nevada, 1949, and as amended by Ordinance No. 696, and subject to plans and specifications as submitted by the applicant on the 16th day of January, 1959, which plans and specifications are on file in the Planning Department of the City of Las Vegas, Nevada.

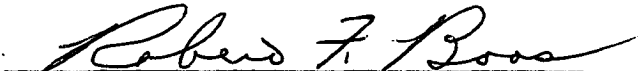
SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

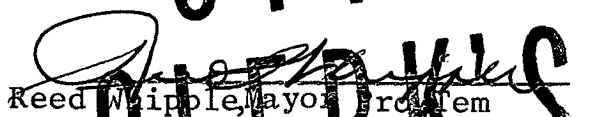

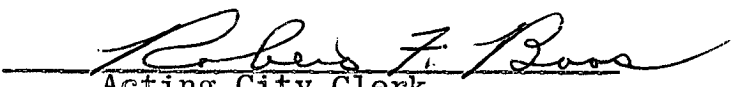

Lots 9 through 16, Block 8, Boulder Addition.

(b) From R-2 to C-1: (Z-15-58)
Lots 1 through 8, Block 4, Billmore Addition, limited, however, as provided in Chapter 24, Section 20, Code of Las Vegas, Nevada, 1949, and as amended by Ordinance No. 654, and subject to plans and specifications as submitted by the applicant on the 18th day of January, 1959, which plans and specifications are on file in the Planning Department of the City of Las Vegas, Nevada.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. The City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas shall cause this ordinance to be published once a week for two successive weeks immediately following its first reading and adoption in a daily newspaper published in the City of Las Vegas, Nevada.
