13 THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA, DOES
14 HEREBY ORDAIN AS FOLLOWS:

15 SECTION 1: Title 10, Chapter 56 of the Municipal Code
16 of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended
17 by adding thereto a new section, designated as Section 35,
18 reading as follows:

19 10.56.035: For purposes of this Chapter, the terms "pool hall"
20 and "billiard room" shall be deemed not to include those
21 establishments where:

- 22 1) coin-operated amusement machines or table games
23 such as table tennis are offered in addition to
24 pool or billiard tables, including coin-operated
25 tables and those for which the user pays in another
26 manner.
- 27 2) the number of pool or billiard tables is one-third
28 or less of the total number of games in the estab-
29 lishment;
- 30 3) no alcohol is sold, served, or consumed; and
31 4) no gaming devices, including pinball machines, are
32 present and no gambling in any form, including


1 betting between players, is permitted.

2 SECTION 2: If any section, subsection, subdivision,
3 paragraph, sentence, clause or phrase in this ordinance or any
4 part thereof is for any reason held to be unconstitutional
5 or invalid or ineffective by any court of competent jurisdiction,
6 such decision shall not affect the validity or effectiveness of
7 the remaining portions of this ordinance or any part thereof.
8 The City Council of the City of Las Vegas, Nevada, hereby declares
9 that it would have passed each section, subsection, subdivision,
10 paragraph, sentence, clause or phrase thereof irrespective of
11 the fact that any one or more sections, subsections, subdivisions,
12 paragraphs, sentences, clauses or phrases be declared unconstitu-
13 tional, invalid or ineffective.


14 SECTION 3: All ordinances or parts of ordinances,

17 1983 Edition, in conflict herewith are hereby repealed.




