10 THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA,
11 DOES HEREBY ORDAIN:

12 SECTION 1: Title 6, Chapter 4, Section 560 of the
13 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition,
14 is hereby repealed in its entirety.

15 SECTION 2: Title 6, Chapter 4 of the Municipal Code
16 of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended
17 by adding thereto a new section, designated as Section 560,
18 reading as follows:

19 6.04.560: (A) The license fee for a time share representative
20 as defined by NRS 119A.120 is one hundred dollars semiannually.

21 (B) The license fee for a time share sales agent as
22 defined by NRS 119A.130 is one hundred dollars semiannually.

23 (C) The license fee for a time share project broker
24 as defined by NRS 119A.090 is one-half of one percent of the
25 total sales volume of time shares on a quarterly basis.

26 SECTION 3: If any section, subsection, subdivision,
27 paragraph, sentence, clause or phrase in this ordinance or any
28 part thereof is for any reason held to be unconstitutional
29 or invalid or ineffective by any court of competent jurisdiction,
30 such decision shall not affect the validity or effectiveness of
31 the remaining portions of this ordinance or any part thereof.

32 The City Council of the City of Las Vegas, Nevada, hereby declares

1 that it would have passed each section, subsection, subdivision,
2 paragraph, sentence, clause or phrase thereof irrespective of
3 the fact that any one or more sections, subsections, subdivisions,
4 paragraphs, sentences, clauses or phrases be declared unconstitu-
5 tional, invalid or ineffective.


6 SECTION 4: All ordinances or parts of ordinances,
