ORDINANCE No. 3181

AN ORDINANCE TO RE-ADOPT TITLE 10, CHAPTER 2, SECTION 10, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, PROVIDING THAT AN OFFENSE MADE A MISDEMEANOR BY THE LAWS OF THE STATE OF NEVADA SHALL ALSO BE A MISDEMEANOR IN THE CITY OF LAS VEGAS WHENEVER SUCH OFFENSE IS COMMITTED WITHIN THE BOUNDARIES OF SAID CITY.

Sponsored By: Councilman Ron Lurie Summary: To re-adopt LVMC 10.02.010 making all State misdemeanors likewise City misdemeanors.

WHEREAS, the Legislature of the State of Nevada, by virtue of the Las Vegas City Charter, has granted to the City Council of said City the power to declare by ordinance that any offense made a misdemeanor by the laws of the State of Nevada shall also be deemed to be a misdemeanor in the City of Las Vegas whenever such offense is committed within the boundaries of said City; and

WHEREAS, the City Council of said City has exercised such power, the ordinance to be found in Title 10, Chapter 2, Section 10 of the Municipal Code of said City; and

WHEREAS, many new criminal laws were enacted by the 1985 Session of the Nevada Legislature, some of which laws became effective on passage and some on July 1, 1985; and

WHEREAS, the City Council of said City desires by this ordinance to re-adopt said Title 10, Chapter 2, Section 10 to include within its purview all of the State misdemeanor laws which are now in effect.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA, DOES ORDAIN AS FOLLOWS:

SECTION 1: Title 10, Chapter 2, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is . . . . .
