

ORDINANCE NO. 1564

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING SECTION 19, SUBSECTION (D) THEREOF TO DELETE PARAGRAPH 4 - "TAVERNS"; TO AMEND SECTION 20, SUBSECTION (A) PARAGRAPH 8 OF SAID TITLE AND CHAPTER TO DELETE THE WORDS "CABARETS, TAVERNS, COCKTAIL LOUNGES OR SERVICE BARS"; TO ELIMINATE DIFFERENTIATION BETWEEN RETAIL LIQUOR FACILITIES SO THAT THEY MAY BE PERMITTED AS A MATTER OF RIGHT IN ANY COMMERCIAL ZONE WHICH PERMITS RETAIL SALES; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH. 1564

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title XI, Chapter 1, Section 19, Subsection (D) is hereby amended by deleting Paragraph 4 thereof - "Taverns".

SECTION 2. Title XI, Chapter 1, Section 20, Subsection (A), Paragraph 8 is hereby amended to read as follows:

11-1-20 (A) 8. Restaurants.

SECTION 3. Any person, firm, or corporation violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

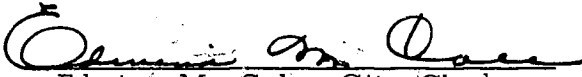

ORDINANCE NO. 1344

AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING SECTION 19, SUBSECTION (D) THEREOF TO DELETE PARAGRAPH 4 "Taverns"; TO AMEND SECTION 20, SUBSECTION (A) PARAGRAPH 1 OF SAID TITLE AND CHAPTER TO DELETE THE WORDS "CABARETS, TAVERNS, COCKTAIL LOUNGES OR SERVICE BARS", TO ELIMINATE DIFFERENTIATION BETWEEN RETAIL LIQUOR FACILITIES SO THAT THEY MAY BE PERMITTED AS A MATTER OF RIGHT IN ANY COMMERCIAL ZONE WHICH PERMITS RETAIL SALES, PROVIDING OTHER MATTERS PROPERLY RELATING THERETO, PROVIDING PENALTIES FOR THE VIOLATION HEREOF, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1: Title XI, Chapter 1, Section 19, Subsection (D) is hereby amended by deleting Paragraph thereof, "Taverns".

SECTION 2: Title XI, Chapter 1, Section 20, Subsection (A), Paragraph 1 is hereby amended to read as follows:

11-120(A)1. Restaurants.

SECTION 3: Any person, firm, or corporation violating any of the provisions of this Ordinance shall, upon conviction thereof, be punished by a fine of not more than \$500.00 and/or imprisonment in the city jail for not more than six (6) months, or any combination of such fine and imprisonment. Every day of such violation shall constitute a separate offense.

SECTION 4: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith, are hereby repealed.
