and Leisure Activities to change number and configuration  
of park districts with city council approval by resolution.

10 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY  
11 ORDAIN AS FOLLOWS:

12 SECTION 1: Title 4, Chapter 24, Section 80, of the Municipal Code of the  
13 City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

14 4.24.080: The City shall be divided into [thirteen] a number of park districts, as the same  
15 [are] shall be depicted on the map that is entitled "Park District Boundaries,"  
16 copies of which are to be maintained for public inspection in the Office of the City  
17 Clerk and the Department of Parks and Leisure Activities, [as] and the same may  
18 from time to time be [amended] changed by number and configuration by the City  
19 Council by a resolution that is duly passed, adopted and approved.

20 SECTION 2: If any section, subsection, subdivision, paragraph, sentence,  
21 clause or phrase in this ordinance or any part thereof, is for any reason held to be  
22 unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision  
23 shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part  
24 thereof. The City Council of the City of Las Vegas hereby declares that it would have passed  
25 each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective  
26 of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses

1 or phrases be declared unconstitutional, invalid or ineffective.

2 SECTION 3: All ordinances or parts of ordinances, sections, subsections,  
3 phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las  
4 Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.


