

Ordinance No 96

An Ordinance of the City of Las Vegas to compel the attendance at meetings of the Board of City Commissioners of the City of Las Vegas by members thereof.

1 The Board of Commissioners of the City of Las Vegas do
2 ordain as follows:

3 Section 1. It shall be and is hereby declared to be
4 the duty of each and every member of the Board of City
5 Commissioners of the City of Las Vegas to attend at least
6 one regular meeting of said Board each month, and also to
7 attend each special meeting thereof upon due notice thereof
8 being given to him. Provided, however, that the absence of
9 such member may be excused on account of sickness of himself or
10 of members of his immediate family residing in said City of
11 Las Vegas, which renders his absence reasonably necessary;
12 and provided further, that such absence may be excused where
13 prior to such meeting leave for such absence may have been
14 given him by said Board of Commissioners or by the Mayor, or
15 by the Mayor Pro. Tem. while acting as Mayor. And, provided
16 further, no such absence shall extend over the period of
17 sixty days.

18 Section 2. In the event of the absence of any member
19 of said Board at any regular or special meeting, except as
20 provided for in Section 1, the said Board of Commissioners,
21 in the event a quorum of such Board is present, or the Mayor,
22 or the Mayor Pro. Tem. while acting as Mayor, in the event a
23 quorum of such Board is not present, may by order direct the
24 City Marshal or any City Policeman of the City of Las Vegas
25 to forthwith apprehend such absent member and bring him forth-
26 with before the said Board, and such officer after bringing such
27 member before the Board shall compel his attendance during
28 the entire session of such Board.

29 Section 3. It shall be the duty of such City Marshal
30 or Policeman, as the case may be, on receiving the order
31 provided in Section 2 of this Ordinance to forthwith execute
32 the same, and after bringing such member before the said
Board to compel his attendance during the entire session of
said Board.

Section 4. This Ordinance shall take effect and be
in force from and after its passage and adoption and publication
for one week (one issue) in Las Vegas Review,
a weekly newspaper published in said City of Las Vegas.

ORDINANCE NO. 96

An Ordinance of the City of Las Vegas to Compel Attendance at Meetings of the Board of City Commissioners of the City of Las Vegas by Members Thereof.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

Section 1. It shall be and is hereby declared to be the duty of each and every member of the Board of City Commissioners of the City of Las Vegas to attend at least one regular meeting of said Board each month, and also to attend each special meeting thereof upon due notice thereof being given to him. Provided, however, that the absence of such member may be excused on account of sickness of himself or of members of his immediate family residing in said City of Las Vegas, which renders his absence reasonably necessary; and provided further, that such absence may be excused where prior to such meeting leave for such absence may have been given him by said Board of Commissioners or by the Mayor, or by the Mayor Pro Tem. while acting as Mayor. And, provided further, no such absence shall extend over the period of sixty days.

Section 2. In the event of the absence of any member of said Board at any regular or special meeting, except as provided for in Section 1, the said Board of Commissioners, in the event a quorum of such Board is present, or the Mayor, or the Mayor Pro Tem. while acting as Mayor, in the event a quorum of such Board is not present, may by order direct the City Marshal or any City Policeman of the City of Las Vegas to forthwith apprehend such absent member and bring him forthwith before the said Board, and such officer after bringing such member before the Board shall compel his attendance during the entire session of such Board.

Section 3. It shall be the duty of such City Marshal or Policeman, as the case may be, on receiving the order provided in Section 2 of this ordinance, to forthwith execute the same, and after bringing such member before the said Board to compel his attendance during the entire session of said Board.

Section 4. This Ordinance shall take effect and be in force from and after its passage and adoption and publication for one week (one issue) in Las Vegas Review, a weekly newspaper published in said City of Las Vegas.

Passed and adopted on the second reading this 6th day of December, A. D. 1922, upon the following vote: Commissioners Arnold, Gorton and Hodgens voting aye. Noes, none.
