

Ordinance No. 141
An Ordinance regulating the parking of vehicles in certain portions of the City of Las Vegas and providing a penalty for the violation thereof, and other matters relating thereto.

Ordinance 141
The Board of Commissioners of the City of Las Vegas Do Ordain as follows:

Section 1. Whenever in this Ordinance the following terms are used they shall have the meanings respectively ascribed to them in this Section.

PARK. To stand a vehicle for a period of time greater than is reasonably necessary for the actual loading or unloading of persons or materials.

BUSINESS DISTRICT. The territory contiguous to a street when fifty per cent (50%) or more of the frontage thereon for a distance of three hundred (300) feet or more is occupied by buildings in use for retail or wholesale business; also any territory contiguous to a street which is immediately adjacent to or a continuation of a street within a business district when such territory is so designated by the Chief of Police.

Section 2. It shall be unlawful for the operator of any vehicle to park the same upon any street for the purpose of displaying it for sale, or to park any vehicle upon any street in any business district from which said vehicle merchandise is being sold.

Section 3. No vehicle shall be left standing over night in any of the alleys of a business district in said City of Las Vegas.

Section 4. No vehicle shall at any time be parked in any of the alleys of said city in such a manner as to obstruct traffic therein, and no vehicle shall at any time be parked in any of the alleys of a business district in said City of Las Vegas.

Section 5. Any person, firm or corporation violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not less than five dollars nor more than one hundred dollars, or by imprisonment in the City Jail for a period of not less than two and one-half days nor more than fifty days, or by both such fine and imprisonment.

Section 6. This Ordinance shall take effect and be in force from and after its passage and publication for a period of one week (three issues) in Las Vegas Age, a Tri-weekly newspaper published in the City of Las Vegas.

Passed as an emergency ordinance by unanimous consent of the whole Board at a recessed regular meeting this 5th day of July, 1929m upon the following vote: Commissioners Harrell, Gorman and his Honor the Mayor J. F. Hesse, voting aye. Smith, Thomas Noes none. First and second reading July 5, 1929.

ORDINANCE NO. 141

The Board of Commissioners of the City of Las Vegas Do Ordain as follows:

Section 1. Whenever in this Ordinance the following terms are used they shall have the meanings respectively ascribed to them in this Section.

BUSINESS DISTRICT. Section 2. It shall be unlawful for the operator of any vehicle to park the same upon any street for the purpose of displaying it for sale, or to park any vehicle upon any street in any business district from which said vehicle merchandise is being sold.

Section 3. No vehicle shall be left standing over night in any of the alleys of a business district in said City of Las Vegas.

Section 4. No vehicle shall at any time be parked in any of the alleys of said city in such a manner as to obstruct traffic therein, and no vehicle shall at any time be parked in

A new city parking ordinance providing for parking in the middle of the newly paved streets; probably will be passed at the meeting of the city board to start at 3 p.m. today, according to Mayor J. F. Hesse.

The proposed ordinance, which would bring about the packing down of the sides of the streets, nearer the curbs, was brought up at the last meeting of the commissioners, and disagreement as to whether the parking should be parallel to the curb or at an angle kept the commissioners from passing the measure.

Any person, firm or corporation violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not less than five dollars (\$5) nor more than one hundred (\$100) dollars, or by imprisonment in the City Jail for a period of not less than two and one-half days nor more than fifty days, or by both such fine and imprisonment.

Section 6. This ordinance shall take effect and be in force from and after its passage and publication for a period of one week (three issues) in The Las Vegas Age, a tri-weekly newspaper published in the city of Las Vegas.

Passed as an emergency ordinance by unanimous consent of the whole Board at a recessed regular meeting this 5th day of July, 1929, upon the following vote: Commissioners Hessel, German, Smith, Thomas, and His Honor the Mayor, J. F. Hesse, voting aye. Noes, none. First and second reading July 5, 1929.
