ORDINANCE NO. 262

AN ORDINANCE OF THE CITY OF LAS VEGAS CONCERNING THE NUMBERING OF BUILDINGS, NUMBERING OF STREETS, AND RE-NAMING OF STREETS: REPEALING ORDINANCE No. 44.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

Section 1. The numbering of all buildings fronting upon the public streets, avenues, and thoroughfares within the City of Las Vegas shall be in conformity with the decimal system and the following rules:

First, The intersection of Main and Fremont streets in Clark's Las Vegas Townsite shall be the initial point of numbering all blocks and buildings in the City of Las Vegas, as follows: 1. All buildings fronting on east and west streets which intersect or start from Main Street, beginning with numbers one (1) and ~~two~~ ^{nought} (0), adjoining said Main Street, shall be numbered progressively, ~~at about twenty five foot centers~~, therefrom through each block. Following the intersection of each numbered street, the numbering shall again begin with numbers one (1) or (0), plus the number of hundreds which is indicated by the number of said intersecting street.

Section 2. All buildings fronting on north and south streets which intersect or start from Fremont Avenue or division street, ^{nought} 1. Beginning with numbers one hundred and one (101) and one hundred and ~~two~~ (100) adjoining said division street, shall be numbered progressively therefrom through each block. Following the intersection with each continuous street, the numbering shall begin with one (1) and ~~two~~ ^{nought} (0) plus the number of hundreds, progressing continuously outward from the division street at one block centers.

All streets which are continuations of existing streets shall bear the name of the existing streets so long as they continue in the same general direction and the names of any streets which are continuations of existing streets that do not bear the same name shall be changed to conform to the above provision.

All continuous north and south streets shall be known as Streets, and all continuous east and west streets shall be known as Avenues, unless they are known as Boulevards or otherwise indicated as different from ordinary streets.

Block numbers assigned to streets at their intersection with the division streets shall be retained throughout their length even though they have an angle point and intermediate streets are interposed between them and their formerly adjacent streets, except in cases where a street intersects two or more streets, with the same general alignment, having different block numbers.

Fremont Avenue shall be the division street, north and south to its intersection with Sunrise Avenue and from that point east, Sunrise Avenue shall become the division street north and south.

Section 3. ~~Buildings fronting on the north and west sides of streets or avenues shall be designated by even numbers, and buildings fronting on the south and east sides of streets or avenues shall be designated by odd numbers. Each odd number shall be placed as nearly as possible opposite the following consecutive even number.~~

Section 4. For the purpose of this Ordinance in connection therewith, the fronts of all lots in Clark's Las Vegas Townsite

1 and all additions to the town or City of Las Vegas, as the same are laid
2 out and recorded in the office of the County Recorder of Clark County, Nevada,
3 shall be divided into parts, approximating twenty-five feet, as nearly as
4 may be, and one number shall be assigned to each of said parts. For the
5 purpose of this Resolution and Ordinance in connection therewith, a block
6 shall be held to mean the space between consecutive streets or avenues in
7 Clark's Las Vegas Townsite or any of the addition to the City of Las Vegas.

8 Section 5. When any street or avenue intersects any other street or
9 avenue from one side only, the numbering on the opposite side of such inter-
10 secting street, or avenue, shall be started at the lot corner most nearly
11 opposite that side of the street which lies farthest from the initial
12 point.

13 Section 6. Any person failing to number his home or building
14 in compliance with the provisions of this ordinance, shall be guilty of a
15 misdemeanor and shall be punished by a fine of not more than Ten (\$10.00)
16 Dollars, or by imprisonment in the city jail for not more than Five (5) days;
17 provided, however, no one shall be guilty of a violation of this ordinance
18 if the requirements of the ordinance are complied with within Thirty (30)
19 days from the date of its passage.

20 Section 7. Ordinance No. 44 of the City of Las Vegas, is hereby
21 repealed.

22 Section 8. The City Clerk is hereby authorized and directed to
23 have this ordinance published in the Las Vegas Evening Review-Journal
24 a daily newspaper published in the City of Las Vegas, for two weeks, that is
25 to say, it shall be published in said paper once a week for two consecutive
26 weeks.

tersection with each continuous
street, the numbering shall begin with
one (1) and nought (0) plus the num-
ber of hundreds, progressing contin-
uously outward from the division
street at one block centers.

All streets which are continuations
of existing streets shall bear the
name of the existing streets so long
as they continue in the same general
direction and the names of any streets
which are continuations of existing
streets that do not bear the same
name shall be changed to conform
to the above provision.

All continuous north and south
streets shall be known as Streets, and
all continuous east and west streets
shall be known as Avenues, unless
they are known as Boulevards or
otherwise indicated as different from
ordinary streets.

Block numbers assigned to streets
at their intersection with the division
streets shall be retained throughout
their length even though they have
an angle point, and intermediate
streets are interposed between them

Ordinance in connection therewith,
the fronts of all lots in Clark's Las
Vegas Townsite and all additions to
the town or City of Las Vegas, as
the same are laid out and recorded
in the office of the County Recorder
of Clark County, Nevada, shall be
divided into parts, approximating
twenty-five feet, as nearly as may
be, and one number shall be assigned
to each of said parts. For the pur-
pose of this Resolution and Ordinance
in connection therewith, a block
shall be held to mean the space be-
tween consecutive streets or avenues
in Clark's Las Vegas Townsite or
any of the addition to the City of
Las Vegas.

Section 5. When any street or
avenue intersects any other street or
avenue, only the num-
bering on the opposite side of such
intersected street or avenue, shall be
started at the lot corner most nearly
opposite that side of the street which
lies farthestmost from the initial
point.

Section 6. Any person failing to
