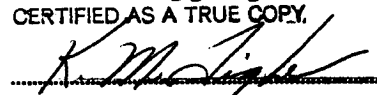

27 together with a certified copy of this ordinance in the office of
28 the County Recorder of Clark County, Nevada, which said recording

1 shall be done prior to the 12th day of February, 1993.

2 SECTION 7: The said described territory, which hereto-
3 fore has been zoned R-E (County of Clark classification), is
4 hereby classified as N-U (City of Las Vegas classification),
5 which is deemed to be the City equivalent of said County classi-
6 fication.

7 SECTION 8: If any section, subsection, subdivision,
8 paragraph, sentence, clause or phrase in this ordinance or any
9 part thereof, is for any reason held to be unconstitutional, or
10 invalid or ineffective by any court of competent jurisdiction,
11 such decision shall not affect the validity or effectiveness of
12 the remaining portions of this ordinance or any part thereof.
13 The City Council of the City of Las Vegas hereby declares that it
14 would have passed each section, subsection, subdivision,
15 paragraph, sentence, clause or phrase thereof irrespective of the
16 fact that any one or more sections, subsections, subdivisions,
17 paragraphs, sentences, clauses or phrases be declared unconstitu-
18 tional, invalid or ineffective.

19 SECTION 9: All ordinances or parts of ordinances, sec-
20 tions, subsections, phrases, sentences, clauses or paragraphs
21 contained in the Municipal Code of the City of Las Vegas, Nevada,
22 1983 Edition, in conflict herewith are hereby repealed.
