AN ORDINANCE TO EXTEND THE JUVENILE CURFEW FOR THE DOWNTOWN AREA ON DECEMBER 31, 1999, AND JANUARY 1, 2000, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Extends the juvenile curfew for the
downtown area on December 31 and January 1.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: On December 31, 1999, and within the following described area, the curfew for persons under the age of eighteen years, as described in LVMC Chapter 10.54, shall be between the hours of six p.m. and five a.m. of the succeeding day:

The area bounded by Washington Avenue on the north, Main Street on the west, Sahara Avenue on the south, and Maryland Parkway on the east, but excepting therefrom any area located within the boundaries of the Pedestrian Mall described in LVMC 11.68.040.

SECTION 2: On January 1, 2000, and within the following described area, the curfew for persons under the age of eighteen years, as described in LVMC Chapter 10.54, shall be between the hours of six p.m. and five a.m. of the succeeding day:

The area bounded by Washington Avenue on the north, Main Street on the west, Sahara Avenue on the south, and Maryland Parkway on the east.

SECTION 3: All other provisions of LVMC Chapter 10.54 shall remain in full force and effect.

SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,

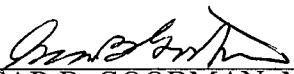
1 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
2 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
3 invalid or ineffective.

4 SECTION 5: Whenever in this ordinance any act is prohibited or is made or declared
5 to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is
6 required or the failure to do any act is made or declared to be unlawful or an offense or a
7 misdemeanor, the doing of such prohibited act or the failure to do any such required act shall
8 constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than
9 \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such
10 fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

11 SECTION 6: All ordinances or parts of ordinances or sections, subsections, phrases,
12 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
13 1983 Edition, in conflict herewith are hereby repealed.

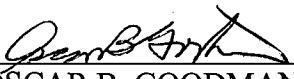

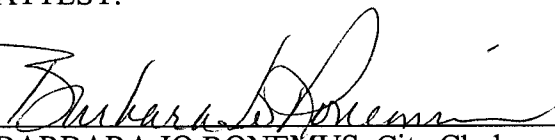

SECTION 2: All other provisions of LVMC Chapter 10.54 shall remain in full force and effect.

SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. 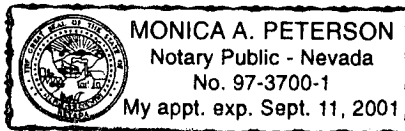

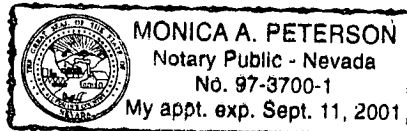
