5 PROVIDING FOR THE INSPECTION OF MEATS AND MEAT PRODUCTS TO BE POSSESSED AND  
6 SOLD IN THE CITY OF LAS VEGAS; PROHIBITING THE SALE AND POSSESSION OF UNINSPECTED

7 That Section Twelve of Ordinance No. 201 is hereby amended by placing a  
8 period after the word "dollars" in line 3 and deleting "and each retail establish-  
9 ment shall pay to the City Clerk a monthly inspection fee of One (\$1.00) Dollar."  
10 so that Section Twelve as amended shall read "Each official slaughtering  
11 establishment designated by the Board of City Commissioners, shall pay to the  
12 City Clerk an annual license fee of Twenty-five (\$25.00) Dollars."
