

EMERGENCY
ORDINANCE NO. 300

AN ORDINANCE TO AMEND SECTION 2 OF ORDINANCE NO. 264 AS AMENDED BY SECTION NO. 1 OF ORDINANCE NO. 286 AND SECTION NO. 8 OF ORDINANCE NO. 264 OF THE CITY OF LAS VEGAS, ENTITLED "AN ORDINANCE OF THE COMMISSION OF THE CITY OF LAS VEGAS, ESTABLISHING A RESIDENCE DISTRICT, INDUSTRIAL AND COMMERCIAL DISTRICTS, WITHIN THE SAID CITY OF LAS VEGAS; DEFINING SUCH DISTRICTS; DECLARING IT UNLAWFUL TO ERECT, ESTABLISH, MAINTAIN OR OPERATE CERTAIN FACTORIES, WORKS OR ESTABLISHMENTS WITHIN SAID RESIDENCE DISTRICTS AND SAID COMMERCIAL DISTRICTS; REGULATING THE ERECTION, ESTABLISHMENT, MAINTENANCE, OPERATION AND REBUILDING OF CERTAIN WORKS OR ESTABLISHMENTS IN SAID DISTRICTS; PROVIDING PENALTIES FOR THE VIOLATION OF SAID ORDINANCE, AND REPEALING ORDINANCES IN CONFLICT HEREWITH," AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

The Board of Commissioners of the City of Las Vegas, do ordain as follows:

Section 1. Section 2 of Ordinance No. 264 as amended by Section 1 of Ordinance No. 286 of the City of Las Vegas entitled, "RESIDENCE ZONE NO. 1" is hereby amended by adding thereto the following paragraph, to-wit:

(e) This zone shall further consist of that portion of said City designated as follows:

All of Sections 34 and 35, Township 20 South, Range 61 East, M. D. B. & M., and all of the Sections 2 and 3, Township 21 South, Range 61 East, M. D. B. & M., lying south of Fremont Street and east of South Fifth Street, but excluding therefrom those portions zoned for Residence Zone No. 2 and Commercial Use. All of the Sections 28, 29, 30, 31, 32, 33, Township 20 South, Range 61 East, M. D. B. & M., and all of Sections 4 and 5, Township 21 South, Range 61 East, lying west of the Union Pacific Railroad main track, but excluding therefrom those portions zoned for Residence Zone No. 4 and Industrial Use. All of the NE $\frac{1}{4}$ and all of the N $\frac{1}{2}$ of the SE $\frac{1}{4}$ of Section 28, Township 20 South, Range 61 East, M. D. B. & M., lying between North Fifth and North Main Street.

Section 2. Section 8 of Ordinance No. 264 of the City of Las Vegas is hereby amended as follows:

That the industrial districts are hereby created and established within said City described as follows:

All of the area bounded by the Union Pacific Railroad Main track on the west, the City limits on the north, the west line of Main Street on the east, and Charleston Boulevard on the south. All of the S $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 27 and all of Section 34 lying west of the Union Pacific Railroad main track; all of the east $\frac{1}{2}$ of the NE $\frac{1}{4}$ and all of the SW $\frac{1}{4}$ of Section 33 lying west of the Union Pacific Railroad main track; all in Township 20 South, Range 61 East, M. D. B. & M. All of the East $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 4, Township 21 South, Range 61 East, M. D. B. & M. Blocks 1, 2, 3, 4, 5, and 6, and the West $\frac{1}{2}$ of Blocks 7, 8, 9, 10, 11 and 12 of the Boulder Addition; and the area bounded by the Meadows Addition on the west, the Boulder Addition on the north, the west line of South Main Street on the east, and the commercial district on the westerly side of South Fifth Street on the south.

Section 3. This ordinance is declared to be and is hereby passed as an EMERGENCY ORDINANCE and it shall take effect immediately after its passage and publication.

Section 4. The City Clerk is hereby authorized to have this Ordinance

Section 1. Section 2 of Ordinance No. 264 as amended by Section 1 of Ordinance No. 286 of the City of Las Vegas entitled, "RESIDENCE ZONE NO. 1" is hereby amended by adding thereto the following paragraph, to-wit:

(e) This zone shall further consist of that portion of said City designated as follows:

All of Sections 34 and 35, Township 20 South; Range 61 East; M. D. B. & M., and all of the Sections 2 and 3, Township 21 South, Range 61 East, M. D. B. & M., lying south of Fremont Street and east of South Fifth Street, but excluding therefrom those portions zoned for Residence Zone No. 2 and Commercial Use. All of the Sections 28; 29, 30, 31, 32, 33, Township 20 South, Range 61 East, M. D. B. & M., and all of Sections 4 and 5, Township 21 South, Range 61 East, lying west of the Union Pacific Railroad main track, but excluding therefrom those portions zoned for Residence Zone No. 4 and Industrial Use. All of the NE 1/4 and all of the N 1/2 of the SE 1/4 of Section 28, Township 20 South, Range 61 East, M. D. B. & M., lying between North Fifth and North Main Street.

Section 2. Section 8 of Ordinance No. 264 of the City of Las Vegas is hereby amended as follows:

That the industrial districts are hereby created and established within said City described as follows:

All of the area bounded by the Union Pacific Railroad main track on the west, the City limits on the north, the west line of Main Street on the east, and Charleston Boulevard on the south. All of the S 1/2 of the SW 1/4 of Section 27 and all of Section 34 lying west of the Union Pacific Railroad main track; all of the E 1/2 of the NE 1/4 and all of the SW 1/4 of Section 33 lying west of the Union Pacific Railroad main track; all in Township 20 South, Range 61 East, M. D. B. & M. All of the East 1/2 of the NE 1/4 of Section 4, Township 21 South, Range 61 East, M. D. B. & M., Blocks 1, 2, 3, 4, 5, and 6, and the W 1/2 of Blocks 7, 8, 9, 10, 11, and 12 of the Boulder Addition; and the area bounded by the Meadows Addition on the west, the Boulder Addition on the north, the west line of South Main Street on the east, and the commercial district on the westerly side of South Fifth Street on the south.

Section 3. This ordinance is declared to be and is hereby passed as an EMERGENCY ORDINANCE and it shall take effect immediately after its passage and publication.
