

1 AN ORDINANCE PROVIDING RULES AND REGULATIONS FOR NURSERIES AND
 2 CHILD CARE FACILITIES WITHIN THE CITY OF LAS VEGAS, NEVADA, AND
 3 REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THERE-
 4 WITH.

5 WHEREAS, THE BOARD OF COMMISSIONERS OF THE CITY OF LAS
 6 VEGAS, DID ON THE 6TH DAY OF AUGUST, 1952, ADOPT ORDINANCE NO.
 7 503 ENTITLED: "AN ORDINANCE TO PROVIDE FOR THE REGULATION AND
 8 LICENSING OF CHILD CARE FACILITIES; AND PERSONS AND ORGANIZATIONS
 9 PROVIDING CARE FOR CHILDREN, AND REPEALING ALL ORDINANCES AND
 10 PARTS OF ORDINANCES IN CONFLICT THEREWITH"; AND

11 WHEREAS, UNDER THE PROVISIONS OF SECTION 2 OF SAID ORDINANCE
 12 NO. 503, THE CHILD WELFARE BOARD OF THE CITY OF LAS VEGAS
 13 WAS TO PROVIDE RULES, REGULATIONS, AND STANDARDS FOR THE ADMINIS-
 14 TRATION OF CHILD CARE FACILITIES AND RECOMMEND THE SAME FOR ADOPT-
 15 ION BY THE BOARD OF COMMISSIONERS; AND

16 WHEREAS, THE SAID RULES AND REGULATIONS WERE FILED WITH
 17 THE CITY CLERK ON THE 4TH DAY OF MARCH, 1953.

18 WHEREAS, NOTICE OF SAID FILING WAS MADE IN THE MANNER
 19 PROVIDED IN THE CHARTER OF THE CITY OF LAS VEGAS;

20 NOW, THEREFORE, THE BOARD OF CITY COMMISSIONERS OF THE
 21 CITY OF LAS VEGAS DO ORDAIN AS FOLLOWS:

22 SECTION 1. THAT A CERTAIN DOCUMENT, THREE (3) COPIES OF
 23 WHICH ARE ON FILE IN THE OFFICE OF THE CITY CLERK OF THE CITY OF
 24 LAS VEGAS, BEING MARKED AND DESIGNATED AS "REGULATIONS FOR NURSER-
 25 IES AND CHILD CARE FACILITIES WITHIN THE CITY OF LAS VEGAS,
 26 NEVADA," PREPARED BY THE CHILD WELFARE BOARD OF THE CITY OF
 27 LAS VEGAS BE AND THE SAME ARE HEREBY ADOPTED FOR THE REGULATION
 28 OF NURSERIES AND CHILD CARE FACILITIES WITHIN THE CITY AND ARE
 29 HEREBY REFERRED TO, AND MADE A PART HEREOF AS IF FULLY SET OUT
 30 IN THIS ORDINANCE.

31 SECTION 2. ALL ORDINANCES OR PARTS OF ORDINANCES IN CON-
 32 FFLICT HERewith ARE HEREBY REPEALED.

SECTION 3. THIS ORDINANCE SHALL BE IN EFFECT FROM AND
 AFTER ITS PASSAGE AND ADOPTION AS PROVIDED IN CHAPTER 11, SEC-
 TION 30 OF THE CHARTER OF THE CITY OF LAS VEGAS.
