

ORDINANCE NO. 531

AN ORDINANCE TO REQUIRE A CHECKING FEE UPON THE SUBMISSION OF A FINAL MAP FOR EACH SUBDIVISION OF REAL PROPERTY WITHIN THE CITY.

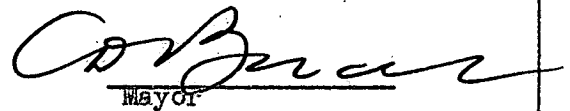
The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. Each final map of a proposed subdivision within the City of Las Vegas shall be accompanied by a checking fee payable to the City of Las Vegas. Such fee shall be in the sum of TWENTY FIVE (\$25.00) DOLLARS, plus the sum of ONE DOLLAR (\$1.00) DOLLARS for each lot or parcel of land delineated on said map.

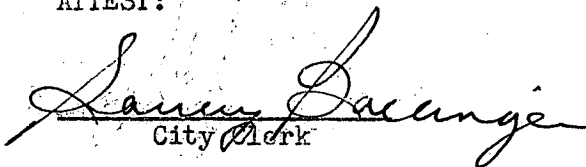
SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. The City Clerk and the Clerk of the Board of Commissioners of the City of Las Vegas shall cause this Ordinance No. 531 to be published once a week for two successive weeks immediately following its final reading and adoption, in the Las Vegas Review Journal, a daily newspaper published in the City of Las Vegas.

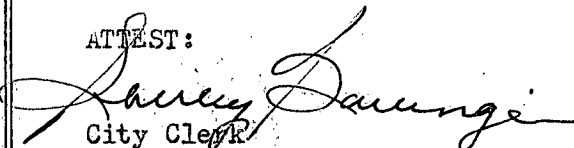
