

ORDINANCE NO. 551

AN ORDINANCE TO AMEND SECTION IV OF ORDINANCE NO. 378 REFERRED TO AS SECTION 10, CHAPTER 24 OF THE LAS VEGAS CITY CODE, 1949, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONE DESIGNATION OF CERTAIN AREAS ON SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

Section 1. The Land Use Plan Map adopted by Section IV of Ordinance No. 378, also referred to as Section 10, Chapter 24, Code of Las Vegas, Nevada, 1949, is hereby amended to read as follows:

From R-3 to R-4

Lots 1 to 12, inclusive, and Lots 27 to 36 inclusive in Block 3; Lots 25 to 36 inclusive in Block 6; and Lots 1 to 8 inclusive in Block 5, all in the Meadows Addition to the City of Las Vegas.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. The City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas shall cause this Ordinance to be published once a week for two successive weeks in the Las Vegas-Sun, a daily newspaper published in the City of Las Vegas.
