

ORDINANCE NO. 560

1 AN ORDINANCE TO AMEND SECTION IV OF ORDINANCE NO. 378, REFERRED TO AS SECTION
2 10, CHAPTER 24, OF THE LAS VEGAS CITY CODE, 1949, BY AMENDING THE LAND USE
3 PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONE DESIGNATION
4 OF CERTAIN AREAS ON THE SAID MAP.

5 The Board of Commissioners of the City of Las Vegas do ordain as
6 follows:

7 SECTION 1. The Land Use Plan Map adopted by Section IV of Ordinance
8 No. 378, also referred to as Section 10, Chapter 24, Code of the City of Las
9 Vegas, 1949, is hereby amended to read as follows:

10 (A) From R-3 to R-4

11 Lot 14, Block 9 of the Boulder Addition to the City of
12 Las Vegas. This property is generally located on South
13 Second Street between Colorado and Imperial Avenues.

14 Lots 1, 2, and 3, Block 3 of the South Fifth Street Tract
15 No. 1. This property is generally located at the south-
16 west corner of St. Louis Street and Paradise Valley Road.

17 Lots 1 to 7 and 31 to 36, inclusive, Block 2
18 Lots 1 to 18 inclusive, and 23 to 41 and unnumbered lot,
19 Block 4;

20 Lots 9 to 14 and 19 to 41 inclusive and unnumbered lot,
21 Block 5;

22 Lots 1 to 18, 23 to 24 and 37 to 46 inclusive, Block 6;

23 Lots 1 to 34 inclusive, Block 10;

24 Lots 1 to 34 inclusive, Block 11;

25 All of Blocks 7, 8, 12, 13, 14, 15, 16 and those portions
26 of the unnumbered lots and blocks lying north of New York
27 Avenue

28 All in the Meadows Addition.

29 SECTION 2. All ordinances or parts of ordinances in conflict
30 herewith are hereby repealed.

31 SECTION 3. This ordinance shall be in full force and effect upon
32 its final reading and adoption, and final publication as in the next section
provided.

SECTION 4. The City Clerk and Clerk of the Board of Commissioners
of the City of Las Vegas shall cause this ordinance to be published once a
week for two successive weeks immediately following its first reading and
adoption in the Las Vegas Review Journal, a daily newspaper published in the
City of Las Vegas.





ORDINANCE NO. 560
AN ORDINANCE TO AMEND SECTION IV OF ORDINANCE NO. 378, REFERRED TO AS SECTION 10, CHAPTER 24, OF THE LAS VEGAS CITY CODE, 1949, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONE DESIGNATION OF CERTAIN AREAS ON THE SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. The Land Use Plan Map adopted by Section IV of Ordinance No. 378, also referred to as Section 10, Chapter 24, Code of the City of Las Vegas, 1949, is hereby amended to read as follows:

(A) Form R-3 to R-4
Lot 14, Block 9 of the Boulder Addition to the City of Las Vegas. This property is generally located on South Second Street between Colorado and Imperial Avenues.

Lots 1, 2, and 3, Block 3 of the South Fifth Street Tract No. 1. This property is generally located at the southwest corner of St. Louis Street and Paradise Valley Road.

Lots 1 to 7 and 31 to 36, inclusive, Block 2 Lots 1 to 18 inclusive, and 23 to 41 and unnumbered lot, Block 4; Lots 9 to 14 and 19 to 41 inclusive and unnumbered lot, Block 5;

Lots 1 to 18, 23 to 24 and 37 to 46 inclusive, Block 6;

Lots 1 to 34 inclusive, Block 10;

Lots 1 to 34 inclusive, Block 11;

All of Blocks 7, 8, 12, 13, 14, 15, 16 and those portions of the unnumbered lots and blocks lying north of New York Avenue.

All in the Meadows Addition.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect upon its final reading and adoption, and final publication as in the next section provided.
