3 AN ORDINANCE TO ADOPT AN UPDATED CONSERVATION ELEMENT OF THE LAS
4 VEGAS 2020 MASTER PLAN, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Adopts an updated Conservation
Element of the Las Vegas 2020 Master Plan.

7 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
8 AS FOLLOWS:

9 SECTION 1: The document entitled "Conservation Element," the essential contents
10 of which were approved by the City Council on May 2, 2012, is hereby adopted as a part of the Las
11 Vegas 2020 Master Plan and is incorporated therein by this reference. The document so identified
12 shall function as the Conservation Element of the Las Vegas 2020 Master Plan, and shall replace and
13 supersede:

14 (A) The previous version of the Conservation Element that was adopted on
15 November 6, 2002, by means of Ordinance No. 5529;

16 (B) Any updates to that Element that have been approved by the City Council
17 between 2002 and the adoption date of this Ordinance; and

18 (C) Any Master Plan element pertaining to water that previously was adopted by
19 the City Council.

20 SECTION 2: The Department of Planning is authorized to:

21 (A) Include the date of the adoption of this Ordinance within or upon the document
22 referred to in Section 1 at such locations as are designed to reflect the date of the adoption of this
23 Ordinance;

24 (B) Publish the document in final form; and

25 (C) File the final document with the City Clerk.

26 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
27 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
28 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or

1 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
2 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
3 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
4 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
5 invalid or ineffective.

6 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
7 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
8 1983 Edition, in conflict herewith are hereby repealed.

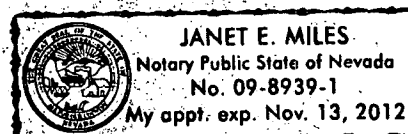
