

AN ORDINANCE CREATING THE POSITION OF ASSISTANT CITY MANAGER; AND PRESCRIBING THE DUTIES THEREOF.

The Board of Commissioners of the City of Las Vegas does ordain as follows:

SECTION 1. There is hereby created an office to be designated as that of Assistant City Manager.

SECTION 2. Any person appointed to this office shall be chosen on the basis of his executive and administrative qualifications with special reference to his actual experience in, or knowledge of, accepted practices in municipal affairs.

SECTION 3. The Assistant City Manager shall perform such duties as may be prescribed by the City Manager and if for any reason the City Manager is absent from the City, sick, or unable to perform the duties of his office the Assistant City Manager shall act for such City Manager and shall be vested with all the power and shall perform all the duties of the City Manager during such absence, or sickness.

SECTION 4. No special bond shall be required of any person filling this position.

SECTION 5. All ordinances or parts of ordinances in conflict herewith are hereby expressly repealed.

SECTION 6. This ordinance shall be in full force and effect upon its publication as in the next section provided, and final passage.

SECTION 7. The City Clerk and Clerk of the Board of Commissioners of the City of Las Vegas shall cause this Ordinance to be published once a week for two successive weeks immediately following its first reading and adoption, in the Las Vegas Sun, a daily newspaper published in the City of Las Vegas.

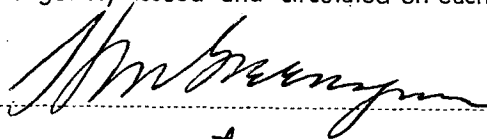

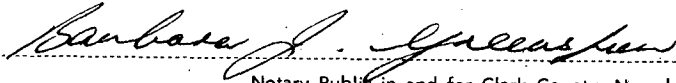
