ORDINANCE NO. 6428

AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE CITY, TO PARTICULARLY DESCRIBE THE LAND TO BE ANNEXED, TO MAKE ITS INHABITANTS SUBJECT TO THE LAWS, OBLIGATIONS AND BENEFITS OF THE CITY, AND TO PROVIDE FOR OTHER RELATED MATTERS. (ANX-58988)

Summary: Annexes property described generally as located on the southwest corner of West Centennial Parkway and Alpine Ridge Way.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The corporate limits of the City of Las Vegas, Nevada, are hereby extended to annex, include, and make a part of the City of Las Vegas, Nevada, the following described real property:

The Northeast Quarter (NE ¼) of the Northeast Quarter (NE ¼) of the Northwest Quarter (NW ¼) of Section 25, Township 19 South, Range 59 east, MDM, Clark County, Nevada.

EXCEPT THEREFROM that portion of the Northeast Quarter (NE ¼) of the Northeast Quarter (NE ¼) of the Northwest Quarter (NW ¼) of said Section 25 conveyed to the County of Clark, a Political Subdivision of the State of Nevada, by that GRANT, BARGAIN, SALE DEED, recorded February 6, 1998 in Book 980206 as Instrument Number 00193 of Clark County, Nevada Records.

1 SECTION 2: The City Council hereby determines that the described territory
2 meets the requirements provided by law for annexation to the City for the following reasons:

3 A. The area to be annexed was contiguous to the City's boundaries at the time
4 the annexation proceedings were instituted;

5 B. More than one-eighth (1/8) of the aggregate external boundaries of the
6 area are contiguous to the City;

7 C. The territory proposed to be annexed is not included within the boundaries
8 of another incorporated city or within the boundaries of any unincorporated town as those
9 boundaries existed as of July 1, 1983;

10 D. The City is eligible to annex the described territory because the
11 landowners have signed a petition constituting one hundred percent (100%) of the owners of record
12 of individual lots or parcels of land within the annexation area.

13 SECTION 3: The City will provide police protection through the Las Vegas
14 Metropolitan Police Department, fire protection, street maintenance, and library services
15 immediately upon annexation. Garbage collection by the company franchised by the City will also
16 be provided immediately. The City sanitary sewer system will serve the proposed annexation area.
17 Any connection to or extension of this sewer line to serve the annexation area shall be at the
18 expense of the landowners. Other services, such as participation in the City's recreational
19 programs, special education classes and programs, public works planning, building inspections, and
20 other City services will also be available immediately. Utilities such as gas, electricity, telephone,
21 and water are provided by private utility companies and other services to the area will not be
22 affected by annexation. Street paving, curbs and gutters, sidewalks and street lights which are not
23 in place at the time of annexation will be installed in the presently developed areas upon the request
24 of the property owners and at their expense by means of special assessment districts. Such
25 improvements will be extended into the undeveloped areas as development takes place and the

1 need therefor arises, and will be located according to the needs of the area at that time. Such
2 installations will also be made at the expense of the property owners, either by means of special
3 assessment districts or as prerequisites to the approval of subdivision plats, building permits or
4 other land use or development applications.

5 SECTION 4: The annexation of the described territory shall become effective
6 on the 10th day of July, 2015, and on that date the City will have the funds appropriated in
7 sufficient amount to finance the extension into the described territory of police protection, fire
8 protection, street maintenance, street sweeping, and street lighting maintenance.

9 SECTION 5: The described territory, together with the inhabitants and property
10 thereof, shall, from and after the 10th day of July, 2015, be subject to all debts, laws, ordinances
11 and regulations in force in the City and shall be entitled to the same privileges and benefits as other
12 parts of the City, and shall be subject to municipal taxes levied by the City.

13 SECTION 6: The City Engineer is hereby instructed to cause to be prepared an
14 accurate map or plat of the described territory and to record the map or plat, together with a
15 certified copy of this ordinance, in the office of the County Recorder of Clark County, Nevada,
16 which recording shall be done prior to the 10th day of July, 2015.

17 SECTION 7: That portion of the described territory, which previously has been
18 zoned R-E (County of Clark classification), is hereby classified as R-E (City of Las Vegas
19 classification), which is deemed to be the City equivalent of the County classification. That portion
20 of the described territory, which previously has been zoned R-D (County of Clark classification), is
21 hereby classified as R-D (City of Las Vegas classification), which is deemed to be the City
22 equivalent of the County classification.

23 SECTION 8: If any section, subsection, subdivision, paragraph, sentence, clause
24 or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or
25 invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the

1 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
2 Council of the City of Las Vegas hereby declares that it would have passed each section,
3 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
4 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
5 declared unconstitutional, invalid or ineffective.


6 SECTION 9: All ordinances or parts of ordinances or sections, subsections,

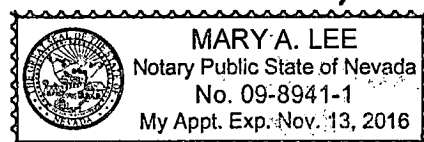
