Summary: Readopts LVMC 10.02.010 to make  
6 State misdemeanors City misdemeanors if  
committed within the City.

7 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS  
8 FOLLOWS:

9 WHEREAS, the Charter of the City of Las Vegas declares that any offense made a  
10 misdemeanor by the laws of the State of Nevada shall also be a misdemeanor in the City of Las Vegas  
11 whenever such offense is committed within the boundaries of the City; and

12 WHEREAS, the City Council has reaffirmed that declaration by means of the adoption of  
13 LVMC 10.02.010; and

14 WHEREAS, a number of criminal laws were enacted or amended by the Nevada  
15 Legislature during its 78th Session, some of which became effective upon passage and approval, and others  
16 of which become effective upon October 1, 2015, or upon some other date specified within those laws; and

17 WHEREAS, the City Council desires by this Ordinance to readopt LVMC 10.02.010 to  
18 include within its purview, to the extent affirmative action to do so is necessary, all the State misdemeanor  
19 laws which have been enacted by the Nevada State Legislature.

20 NOW, THEREFORE, BASED UPON THE FOREGOING, THE CITY COUNCIL OF  
21 THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

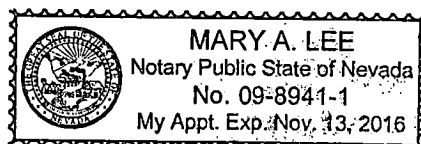
