10 AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE CITY, TO PARTICULARLY

12 THE LAWS, OBLIGATIONS AND BENEFITS OF THE CITY, AND TO PROVIDE FOR
OTHER RELATED MATTERS. (ANX-59663)

14 located at 4008 West Vegas Drive.

15 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
16 ORDAIN AS FOLLOWS:

17 SECTION 1: The corporate limits of the City of Las Vegas, Nevada, are hereby
18 extended to annex, include, and make a part of the City of Las Vegas, Nevada, the following
19 described real property:

20 That portion of the Southwest Quarter (SW 1/4) of the Southeast Quarter (SE 1/4)
21 of Section 19, Township 20 South, Range 61 East, M.D.M., of Clark County
22 Nevada, being Lot 14 in Block 11 as shown on EASTLAND HEIGHTS TRACT
23 NO. 2 recorded in Book 2 of Plats Page 67 of Clark County, Nevada records,
together with the adjoining 40.00 foot half street right of way of Vegas Drive
described as follows:

24 COMMENCING at the South Quarter (S 1/4) corner of said Section 19; thence
25 along the south line of said Southwest (SW 1/4) and the centerline of said Vegas
Drive (half street 40.00 feet wide), South 89°55'00" East 1,054.83 feet to the
POINT OF BEGINNING; thence continuing along said south line and said

1 centerline, South 89°55'00" East 100.00 feet; thence departing said south line and
2 said centerline, North 00°05'00" East 40.00 feet to the north right of way line of
3 said Vegas Drive at the southeast corner of said Lot 14 thence continuing
4 North 00°05'0" East 195.00 feet along the east line thereof to the northeast corner
5 of said Lot 14; thence along the north line of said Lot 14 North 89°55'00" West
6 100.00 feet to the northwest corner of said Lot 14; thence along the west line of
7 said Lot 14, South 00°05'00" West 195.00 feet to the southwest corner of said Lot
8 14 at north right of way line of said Vegas Drive; thence continuing South
9 00°05'00" West 40.00 feet to the POINT OF BEGINNING.

10 BASIS OF BEARINGS: South 89°55'00" East, being the south line of the
11 Southwest Quarter (SW 1/4) of the Southeast Quarter (SE 1/4) of Section 19,
12 Township 20 South, Range 61 East M.D.M., as shown on Book 2 of Plats, Page 67
13 of Clark County, Nevada Records.

22 SECTION 2: The City Council hereby determines that the described territory
23 meets the requirements provided by law for annexation to the City for the following reasons:

24 A. The area to be annexed was contiguous to the City's boundaries at the time
25 the annexation proceedings were instituted;

26 B. More than one-eighth (1/8) of the aggregate external boundaries of the
27 area are contiguous to the City;

28 C. The territory proposed to be annexed is not included within the boundaries
29 of another incorporated city or within the boundaries of any unincorporated town as those
30 boundaries existed as of July 1, 1983;

31 D. The City is eligible to annex the described territory because the present or
32 previous landowners have signed a petition constituting one hundred percent (100%) of the owners
33 of record of individual lots or parcels of land within the annexation area.

34 SECTION 3: The City will provide police protection through the Las Vegas

1 Metropolitan Police Department, fire protection, street maintenance, and library services
2 immediately upon annexation. Garbage collection by the company franchised by the City will also
3 be provided immediately. The City sanitary sewer system will serve the proposed annexation area.
4 Any connection to or extension of this sewer line to serve the annexation area shall be at the
5 expense of the landowners. Other services, such as participation in the City's recreational
6 programs, special education classes and programs, public works planning, building inspections, and
7 other City services will also be available immediately. Utilities such as gas, electricity, telephone,
8 and water are provided by private utility companies and other services to the area will not be
9 affected by annexation. Street paving, curbs and gutters, sidewalks and street lights which are not
10 in place at the time of annexation will be installed in the presently developed areas upon the request
11 of the property owners and at their expense by means of special assessment districts. Such
12 improvements will be extended into the undeveloped areas as development takes place and the
13 need therefor arises, and will be located according to the needs of the area at that time. Such
14 installations will also be made at the expense of the property owners, either by means of special
15 assessment districts or as prerequisites to the approval of subdivision plats, building permits or
16 other land use or development applications.

17 SECTION 4: The annexation of the described territory shall become effective
18 on the 11th day of September, 2015, and on that date the City will have the funds appropriated in
19 sufficient amount to finance the extension into the described territory of police protection, fire
20 protection, street maintenance, street sweeping, and street lighting maintenance.

21 SECTION 5: The described territory, together with the inhabitants and property
22 thereof, shall, from and after the 11th day of September, 2015, be subject to all debts, laws,
23 ordinances and regulations in force in the City and shall be entitled to the same privileges and
24 benefits as other parts of the City, and shall be subject to municipal taxes levied by the City.

25 SECTION 6: The City Engineer is hereby instructed to cause to be prepared an

1 accurate map or plat of the described territory and to record the map or plat, together with a
2 certified copy of this ordinance, in the office of the County Recorder of Clark County, Nevada,
3 which recording shall be done prior to the 11th day of September, 2015.

4 SECTION 7: The described territory, which previously has been zoned R-E
5 (County of Clark classification), is hereby classified as R-E (City of Las Vegas classification),
6 which is deemed to be the City equivalent of the County classification.

7 SECTION 8: If any section, subsection, subdivision, paragraph, sentence, clause
8 or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or
9 invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
10 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
11 Council of the City of Las Vegas hereby declares that it would have passed each section,
12 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
13 any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be
14 declared unconstitutional, invalid or ineffective.

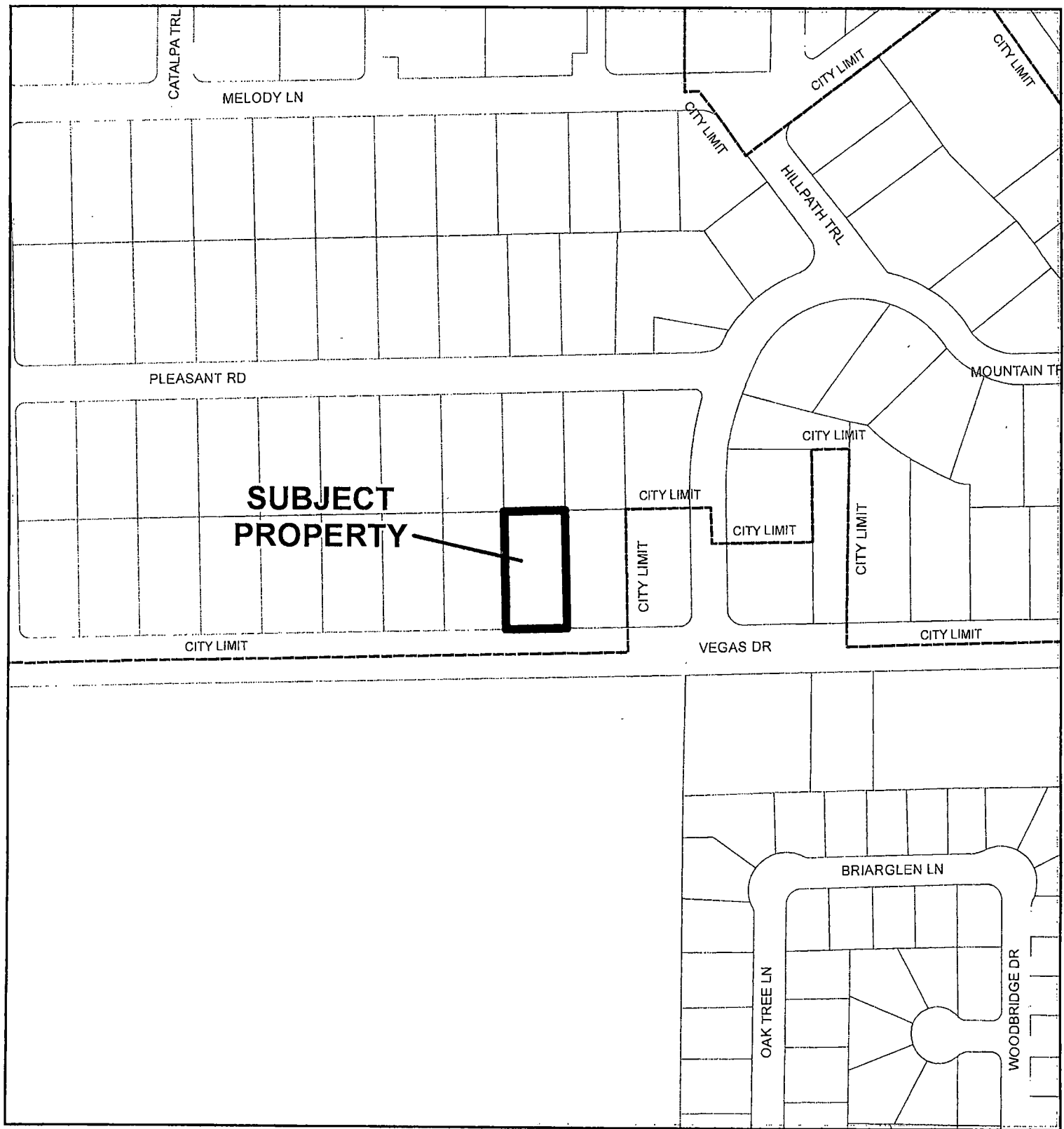

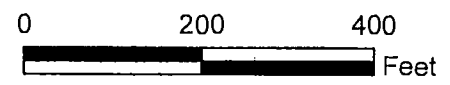

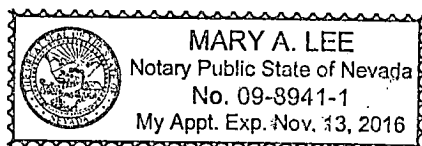
