ORDINANCE NO. 6553

AN ORDINANCE TO REVISE THE LIMITATIONS PERTAINING TO THE KEEPING OF POTBELLIED PIGS ON RESIDENTIAL LOTS, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Revises the limitations pertaining to the keeping of potbellied pigs on residential lots.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 7, Chapter 38, Section 41, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

7.38.041: Potbellied pigs [maintained, possessed or kept in a detached single-family residence must:

- (A) Weigh not in excess of one hundred twenty pounds;
- (B) Be not in excess of twenty-two inches in height;
- (C) Be appropriately vaccinated; and
- (D) Be neutered or spayed.] kept or maintained at a detached single-family residence

must be:

- (A) For the use or enjoyment of the owner or resident;
- (B) Incidental to the residential use;
- (C) Appropriately vaccinated; and
- (D) Neutered or spayed.

SECTION 2: Title 7, Chapter 38, Section 42, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

7.38.042: (A) Owners of a potbellied pig maintained, possessed or kept [in] at a detached single-family residence must obtain an annual permit from the City, and at the time of application must:

(1) Pay a fifty dollar annual licensing permit fee;

(2) Submit proof that the animal meets the requirements of Section 7.38.041.

(B) The permit required in Subsection (A) shall be obtained within thirty days after the potbellied pig attains the age of four months or is first brought into the City.

SECTION 3: Title 7, Chapter 38, Section 43, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

7.38.043: [A maximum of one potbellied pig may be maintained, possessed or kept at a detached single-family residence.] The maximum number of potbellied pigs that may be kept or maintained at a detached single-family residence is as set forth in the table below:

<u>LOT SIZE (IN SQUARE FEET)</u>	<u>MAXIMUM NUMBER OF POTBELLIED PIGS</u>
<u>Less than 13,200</u>	<u>1</u>
<u>13,200 or greater, but less than 20,000</u>	<u>2</u>
<u>20,000 or greater</u>	<u>3</u>

SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 5: Whenever in this ordinance any act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such fine and imprisonment. Any day of any violation

1 of this ordinance shall constitute a separate offense.

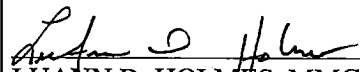
2 SECTION 6: All ordinances or parts of ordinances or sections, subsections, phrases,

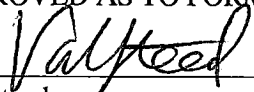

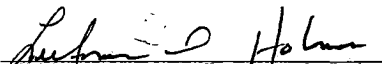

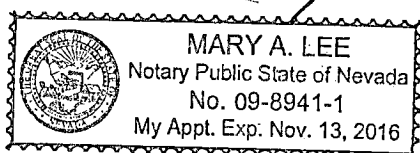
