3 AN ORDINANCE TO AUTHORIZE THE CITY, THROUGH ITS DEPARTMENT OF YOUTH  
4 DEVELOPMENT AND SOCIAL INNOVATION, TO DEVELOP, PROVIDE FOR AND OPERATE  
5 PRE-KINDERGARTEN AND EARLY CHILDHOOD EDUCATION PROGRAMS WITHIN THE CITY,  
6 AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Authorizes the City, through its  
Department of Youth Development and Social  
Innovation, to develop, provide for and operate  
pre-kindergarten and early childhood education  
programs within the City.

9 WHEREAS, during its 2015 Legislative Session, the Nevada Legislature enacted NRS  
10 268.001 to 268.0035, inclusive, authorizing governing bodies of incorporated cities in Nevada to exercise  
11 powers necessary or proper to address matters of local concern for the effective operation of city  
12 government, subject to certain limitations; and

13 WHEREAS, the City Council has determined that the operation of pre-kindergarten and  
14 early childhood education programs within the City of Las Vegas qualifies as a matter concerning which  
15 such authority may be exercised.

16 NOW, THEREFORE, BASED UPON THE FOREGOING, THE CITY COUNCIL OF  
17 THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

18 SECTION 1: The City, through its Department of Youth Development and Social  
19 Innovation, is authorized to develop, provide for and operate pre-kindergarten and early childhood  
20 education programs within the City, in accordance with established Department and City objectives. The  
21 City Council may establish additional parameters from time to time by ordinance or resolution.

22 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or  
23 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or  
24 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or  
25 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City  
26 of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph,

1 sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections,  
2 subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.


3 SECTION 3: All ordinances or parts of ordinances or sections, subsections, phrases,  
4 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983  
5 Edition, in conflict herewith are hereby repealed.


