ORDINANCE NO. 6598

AN ORDINANCE TO AMEND LVMC 7.38.043 TO INCREASE THE NUMBER OF POTBELLIED PIGS THAT MAY BE KEPT AT A DETACHED SINGLE-FAMILY RESIDENCE, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Sponsored by: Councilwoman Lois Tarkanian

Summary: Amends LVMC 7.38.043 to increase the number of potbellied pigs that may be kept at a detached single-family residence.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 7, Chapter 38, Section 43, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

7.38.043: The maximum number of potbellied pigs that may be kept or maintained at a detached single-family residence is as set forth in the table below:

LOT SIZE (IN SQUARE FEET)	MAXIMUM NUMBER OF POTBELLIED PIGS
Less than 13,200	[1] <u>2</u>
13,200 or greater, but less than 20,000	[2] <u>3</u>
20,000 or greater	[3] <u>4</u>

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 3: Whenever in this ordinance any act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon

conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

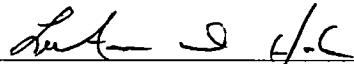

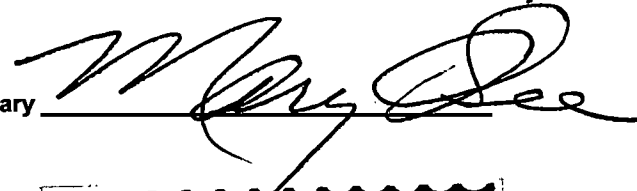

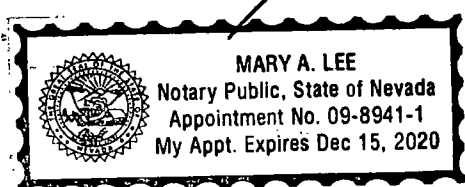
