ORDINANCE NO. 6601

AN ORDINANCE TO AMEND THE CITY'S ADMINISTRATIVE CODE ADOPTED BY LVMC 16.02.010 TO REQUIRE BABY CHANGING TABLES IN CERTAIN PUBLIC ACCOMMODATIONS AS REQUIRED BY ASSEMBLY BILL 241 OF THE 2017 SESSION OF THE NEVADA LEGISLATURE, AND TO PROVIDE FOR OTHER RELATED MATTERS

Summary: Amends the City's Administrative Code adopted by LVMC 16.02.010 to require baby changing tables in certain public accommodations as required by Assembly Bill 241 of the 2017 Session of the Nevada Legislature.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
FOLLOWS:

WHEREAS, Assembly Bill 241 of the 2017 Session of the Nevada Legislature requires each local government to adopt requirements for baby changing tables in certain buildings and facilities open to the public.

NOW, THEREFORE, BASED UPON THE FOREGOING, THE CITY COUNCIL OF
THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The document entitled "City of Las Vegas Administrative Code, 2012 Edition," adopted by LVMC 16.02.010, is hereby amended by adding thereto a new chapter, designated as Chapter 8 and consisting of Section 801, reading as follows:

SECTION 801 – BABY CHANGING TABLES

Any permanent building or facility used by the public that contains a public restroom and is constructed on or after October 1, 2017, shall be equipped with at least one baby changing table. If a baby changing table is not accessible in such a building or facility to both men and women, the building or facility shall be equipped with at least one baby changing table accessible to men and at least one baby changing table accessible to women. For purposes of this Section, "baby changing table" means a safe, sanitary and convenient station, table or similar amenity that allows for the changing of a baby's diaper or clothing.

EXCEPTION:

The requirements of this Section do not apply to buildings or facilities that have been issued a permit or license which restricts admission of children to the building or facility on the basis of age.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

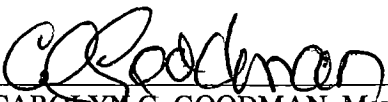
SECTION 3: Whenever in this ordinance any act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

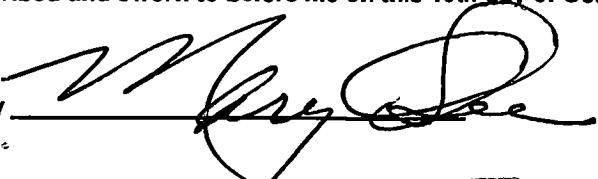

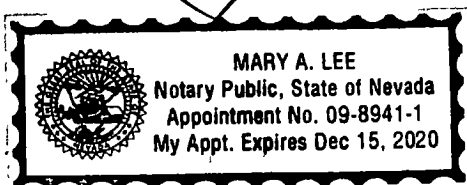
