3 AN ORDINANCE TO AMEND LVMC SECTION 19.12.010 TO ALLOW THE USE "TATTOO
4 PARLOR/BODY PIERCING STUDIO" IN THE C-1 ZONING DISTRICT BY MEANS OF SPECIAL
USE PERMIT, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Studio" in the C-1 Zoning District by means of

8 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
9 FOLLOWS:

10 SECTION 1: Ordinance No. 6289 and the Unified Development Code adopted as Title
11 19 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, are hereby amended as set forth
12 in Section 2 of this Ordinance. The amendment in Section 2 is deemed to be an amendment to both
13 Ordinance No. 6289 and the Unified Development Code adopted as Title 19.

14 SECTION 2: Table 2 of the Land Use Tables adopted in Title 19, Chapter 12, Section
15 10, is hereby amended by amending the entry for the use "Tattoo Parlor/Body Piercing Studio" to indicate
16 that the use is allowed by means of special use permit in the C-1 Zoning District. In order to reflect the
17 amendment, the letter "S" shall be inserted in the box that represents the intersection of the row for the use
18 "Tattoo Parlor/Body Piercing Studio" and the column for the C-1 Zoning District.

19 SECTION 3: For purposes of Section 2.100(3) of the City Charter, Section 19.12.010 is
20 deemed to be a subchapter rather than a section.

21 SECTION 4: The Department of Planning is authorized and directed to incorporate into
22 the Unified Development Code the amendment contained in Section 2 of this Ordinance.

23 SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or
24 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
25 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
26 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City

1 of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph,
2 sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections,
3 subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

4 SECTION 6: All ordinances or parts of ordinances or sections, subsections, phrases,
5 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983
6 Edition, in conflict herewith are hereby repealed.

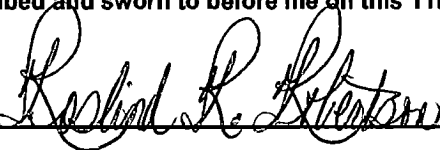

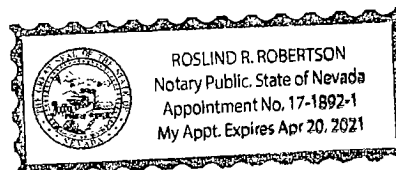
