ORDINANCE NO. 6628

AN ORDINANCE TO AUTHORIZE THE CITY COUNCIL TO CONSIDER AND DECIDE THE MERITS OF ANY APPLICATION OR PROPOSED LEGISLATIVE MEASURE THAT HAS BEEN TABLED OR HELD IN ABEYANCE BY A BOARD, COMMISSION OR COMMITTEE UNDER CERTAIN CIRCUMSTANCES AND CONDITIONS, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Sponsored by: Mayor Carolyn G. Goodman

Summary: Authorizes the City Council to consider and decide the merits of any application or proposed legislative measure that has been tabled or held in abeyance by a board, commission or committee under certain circumstances and conditions.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Notwithstanding any contrary or inconsistent provision of the Las Vegas Municipal Code, and subject to the provisions of Sections 2 and 3, the City Council may consider and decide the merits of any application or proposed legislative measure that has been tabled or held in abeyance by a board, commission or committee under the following circumstances and conditions:

(A) The board, commission or committee has been created by the City Council for purposes of providing review and an initial decision, or a recommendation to the City Council;

(B) The application or measure is one that is required by the Municipal Code to be considered by the board, commission or committee before it is able to be heard by the City Council; and

(C) The board, commission or committee has:

(1) Tabled the application or measure indefinitely (other than at the request of the applicant or City staff); or

(2) Held the application or measure in abeyance more than once or for a cumulative period of more than one month (other than at the request of the applicant, sponsor or City staff).

SECTION 2: Before the City Council may exercise its authority under Section 1 of this Ordinance regarding an application or legislative measure, the Council must first approve a motion to

1 exercise that authority regarding the application or measure in question. An agenda item by which the
2 Council may consider such a motion may be requested by any member of the City Council.


3 SECTION 3: Any action taken under Sections 1 and 2 of this Ordinance is subject to all
4 applicable requirements of State law as well as the notice requirements of LVMC Title 19.

5 SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
6 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
7 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
8 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
9 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
10 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
11 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.


12 SECTION 5: All ordinances or parts of ordinances or sections, subsections, phrases,

14 Edition, in conflict herewith are hereby repealed.



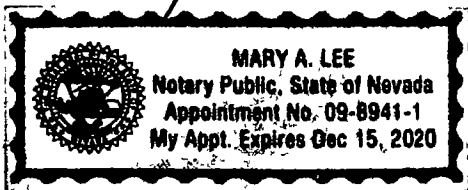
