ORDINANCE NO. 6629

AN ORDINANCE RELATED TO VEHICLE PARKING; AMENDING VARIOUS PROVISIONS OF LVMC TITLE 11 TO SPECIFICALLY PROVIDE FOR ENFORCEMENT OF NON-METERED PAID VEHICLE PARKING IN CITY-OWNED OR CITY-LEASED PARKING LOTS; AMENDING THE DEFINITION OF "TOUR BUS" FOR PARKING PURPOSES TO CLARIFY THAT IT DOES NOT INCLUDE LIMOUSINES; AND PROVIDING FOR OTHER RELATED MATTERS.

Summary: Amends various provisions of LVMC Title 11 to specifically provide for enforcement of non-metered paid vehicle parking in City-owned or City-leased parking lots, and amends the definition of "tour bus" for parking purposes to clarify that it does not include limousines.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 11, Chapter 52, Section 310, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11.52.310: The City Manager is authorized to limit parking on City-owned or City-leased parking lots to certain specified persons, for designated purposes, and for certain specific lengths of time, and to erect signs giving notice of such limitations. In a non-metered lot or garage, such limitations may include, among other things, the requirement to pay a fee for parking that is collected upon entrance or exit.

SECTION 2: Title 11, Chapter 52, Section 320, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11.52.320: When signs are erected giving notice thereof, it shall be unlawful for any person to park a vehicle on City-owned or City-leased parking lots in violation of such limitations[.], including the failure to pay a required parking fee in accordance with LVMC 11.52.310.

SECTION 3: Title 11, Chapter 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 160, reading as follows:

11.10.160: In the case of a failure to pay a required parking fee as referenced in LVMC 11.52.310 and

1 11.52.320, the City is entitled to collect the required parking fee in addition to and independent of any civil
2 fine that may be imposed, and the fee amount shall be added to and be collectible with the amount of fines
3 and penalties associated with the violation.

4 SECTION 4: Title 11, Chapter 2, Section 150, of the Municipal Code of the City of Las
5 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6 **11.02.150:** "Tour bus" or "shuttle bus" means a motor vehicle, other than a limousine, which is
7 designed, maintained and used to transport more than six persons, including the driver, to or from hotels,
8 motels, casinos, cultural or athletic events or other tourist attractions or points of interest.

9 SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
10 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
11 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
12 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
13 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
14 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
15 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

16 SECTION 6: Whenever in this ordinance any act is prohibited or is made or declared to
17 be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required
18 or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of
19 such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon
20 conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of
21 not more than six months, or by any combination of such fine and imprisonment. Any day of any violation
22 of this ordinance shall constitute a separate offense.

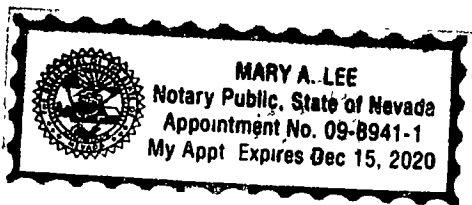
