ORDINANCE NO. 6646

AN ORDINANCE TO GENERALLY PROHIBIT THE FEEDING OF WILD PIGEONS, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Sponsored by: Councilwoman Lois Tarkanian Summary: Generally prohibits the feeding of wild pigeons.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 7, Chapter 4, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 510, reading as follows:

7.04.510: "Wild pigeon" means any common pigeon of the species *columba livia*, also known as a city pigeon, rock dove, rock pigeon or flying rat.

SECTION 2: Title 7, Chapter 38, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to add thereto a new section, designated as Section 7.38.055, reading as follows:

7.38.055: (A) Except as otherwise provided in Subsection (B), it is unlawful and a public nuisance for any person to encourage the lingering, roosting or congregating of wild pigeons by providing food intended for ingestion by wild pigeons, whether on public property or private residential property. For purposes of the preceding sentence, "food" includes without limitation grain, seeds, greens, bread crumbs, and miscellaneous food scraps.

(B) The prohibition contained in Subsection (A) does not apply to any feeding of pigeons that may take place pursuant to a permit granted under this Chapter.

SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or

1 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City
2 of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph,
3 sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections,
4 subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

5 SECTION 4: Whenever in this ordinance any act is prohibited or is made or declared to
6 be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required
7 or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of
8 such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon
9 conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of
10 not more than six months, or by any combination of such fine and imprisonment. Any day of any violation
11 of this ordinance shall constitute a separate offense.


12 SECTION 5: All ordinances or parts of ordinances or sections, subsections, phrases,



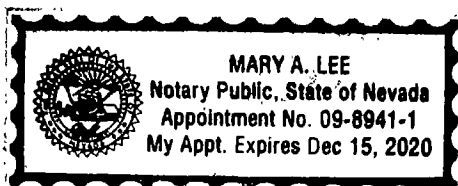
