ORDINANCE NO. 6667

AN ORDINANCE TO AMEND THE INTERIM DOWNTOWN LAS VEGAS DEVELOPMENT STANDARDS SET FORTH IN APPENDIX F OF THE UNIFIED DEVELOPMENT CODE (TITLE 19) TO REFLECT THE RECENT ADOPTION OF LVMC CHAPTER 19.09 PERTAINING TO FORM-BASED CODES, AS WELL AS OTHER RECENT RELATED ACTIONS TAKEN BY THE CITY COUNCIL REGARDING THE MASTER PLAN AND THE LAS VEGAS MEDICAL DISTRICT, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Amends the Interim Downtown Las Vegas Development Standards set forth in Appendix F of the Unified Development Code (Title 19) to reflect the recent adoption of LVMC Chapter 19.09, pertaining to form-based codes, as well as other recent related actions taken by the City Council regarding the Master Plan and the Las Vegas Medical District.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Ordinance No. 6289 and the Unified Development Code adopted as Title 19 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, are hereby amended as set forth in Sections 2 to 8, inclusive, of this Ordinance. All amendments are (and all references to Appendix F refer) to Appendix F of the Unified Development Code, which contains and is titled Interim Downtown Las Vegas Development Standards. Deleted material is indicated in brackets, while new material is underlined. The amendments are deemed to be amendments to Ordinance No. 6289 and the Unified Development Code adopted as Title 19.

SECTION 2: Section A of Appendix F is hereby amended by replacing Figure 2 with an updated Figure 2 as depicted in the attached Exhibit A.

SECTION 3: Section A.4.c.i of Appendix F is hereby amended to read as follows:
i. Area 3a: The Las Vegas Medical District, as [defined in the Las Vegas Medical District Plan adopted by City Council on June 19, 2002] described in LVMC Chapter 19.09.

SECTION 4: Section A.6 of Appendix F is hereby amended to read as follows:

6. Relationship to other Documents

The DTLV-O (Downtown Las Vegas Overlay) is the primary regulating document for all development and improvements within the DTLV-O boundaries. Other documents relating to the physical development of properties that are referenced in the DTLV-O (Downtown Las Vegas Overlay) include Title 19 of the Las Vegas Municipal Code[, the Las Vegas Medical District Plan,] and the Symphony Park Design Standards.

The DTLV-O (Downtown Las Vegas Overlay) complements and coordinates with the Redevelopment Plan for the Downtown Las Vegas Redevelopment Area, as adopted March 5, 1986, and amended thereafter.

All development plans within the DTLV-O area (Fig. 1) shall comply with the adopted DTLV-O (Downtown Las Vegas Overlay) as well as all other applicable regulations in the city, county, state and Federal jurisdictions. These standards are not intended to override or contradict the city of Las Vegas codes or requirements. Where differences occur, the most stringent shall apply in all cases.

SECTION 5: Section B.3.h of Appendix F is hereby amended to read as follows:

h. Las Vegas Medical District

Goal: The center of health, education, and research for Southern Nevada

Description: With proximity to the core as a significant employment node, the Las Vegas Medical District (LVMD) shows great potential for driving the medical-oriented economy while complementing other districts of Downtown. Several millions of square feet of development are proposed, creating a mixed use, walkable, and healthy neighborhood through several reinvestment strategies, including focusing mixed-use development along major streets, reinforcing green linkages, and completion of a convenient transit line linking the LVMD to the Civic & Business and Resort & Casino districts, as well as UNLV and McCarran International Airport. The UNLV Medical School will function as the primary anchor for activity in this District. [For further details, refer to the Las Vegas Medical District Plan.

Non-Compatible Title 19 Zoning Districts: Detailed standards for zoning districts and land uses in the Las Vegas Medical District (LVMD) have been established through the adoption of the Las Vegas Medical District Plan, and therefore there is no table for “Non-Compatible Title 19 Zoning Districts”. Instead, for the list of allowed and prohibited land uses within the LVMD refer to Table 1 of the Las Vegas Medical District

1 Plan "LVMD Permitted Uses".]

2 SECTION 6: Section C of Appendix F is hereby amended by replacing Figure 32 and 33
3 with updated Figures 32 and 33 as depicted in the attached Exhibits B and C, respectively.

4 SECTION 7: Section C.3.a.i of Appendix F is hereby amended to read as follows:

5 **i. Las Vegas Medical District**

6 All development occurring within Area 3a of the DTLV-O (Downtown Las Vegas Overlay) shall conform
7 to [the Las Vegas Medical District Plan, as adopted by the Las Vegas City Council on June 19, 2002 and
8 amended through August 1, 2007.] LVMC Chapter 19.09.

9 SECTION 8: Section C.3.b of Appendix F is hereby amended to read as follows:

10 Except as otherwise provided in this Subparagraph (b), [Any] any deviation from the development standards
11 that supports the City's goals as expressed in the Vision 2045 Downtown Las Vegas Masterplan and the
12 districts' goals and descriptions as per Chapter II of this document may only be granted by the City Council
13 when supported through clear and convincing evidence, and shall require the approval of a Waiver per
14 Section A.8.b of this document.

15 Deviations from development standards set forth in LVMC Chapter 19.09 shall be in accordance with the
16 procedures set forth in that chapter.

17 SECTION 9: The Department of Planning is authorized and directed to incorporate into
18 the Unified Development Code the amendments set forth in Sections 2 to 8, inclusive, of this Ordinance,
19 including the removal of ordinance exhibit labels and any other formatting and relabeling adjustments as are
20 deemed necessary.

21 SECTION 10: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
22 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
23 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
24 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
25 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
26 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,

1 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

2 SECTION 11: All ordinances or parts of ordinances or sections, subsections, phrases,
3 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983
4 Edition, in conflict herewith are hereby repealed.

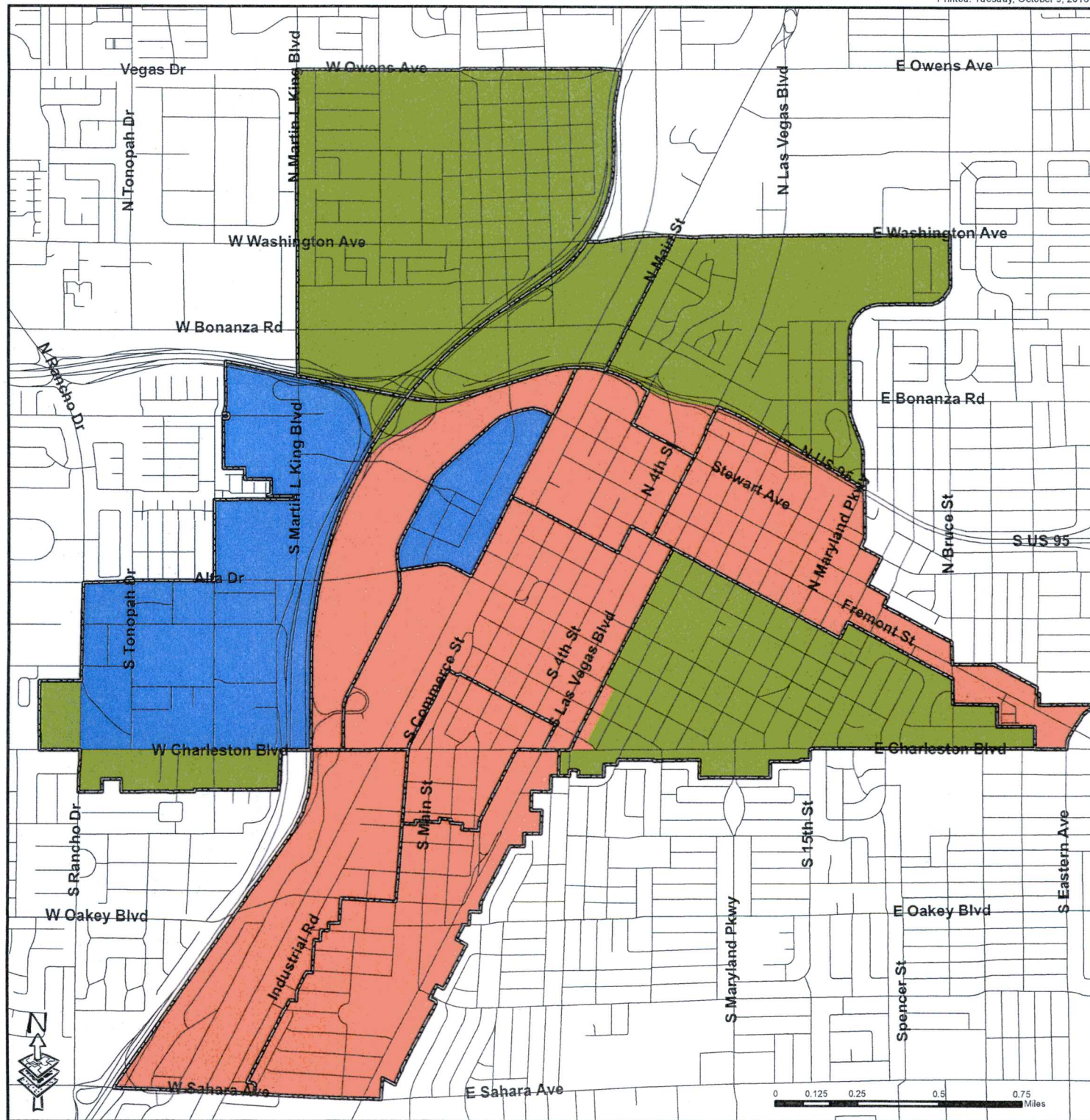

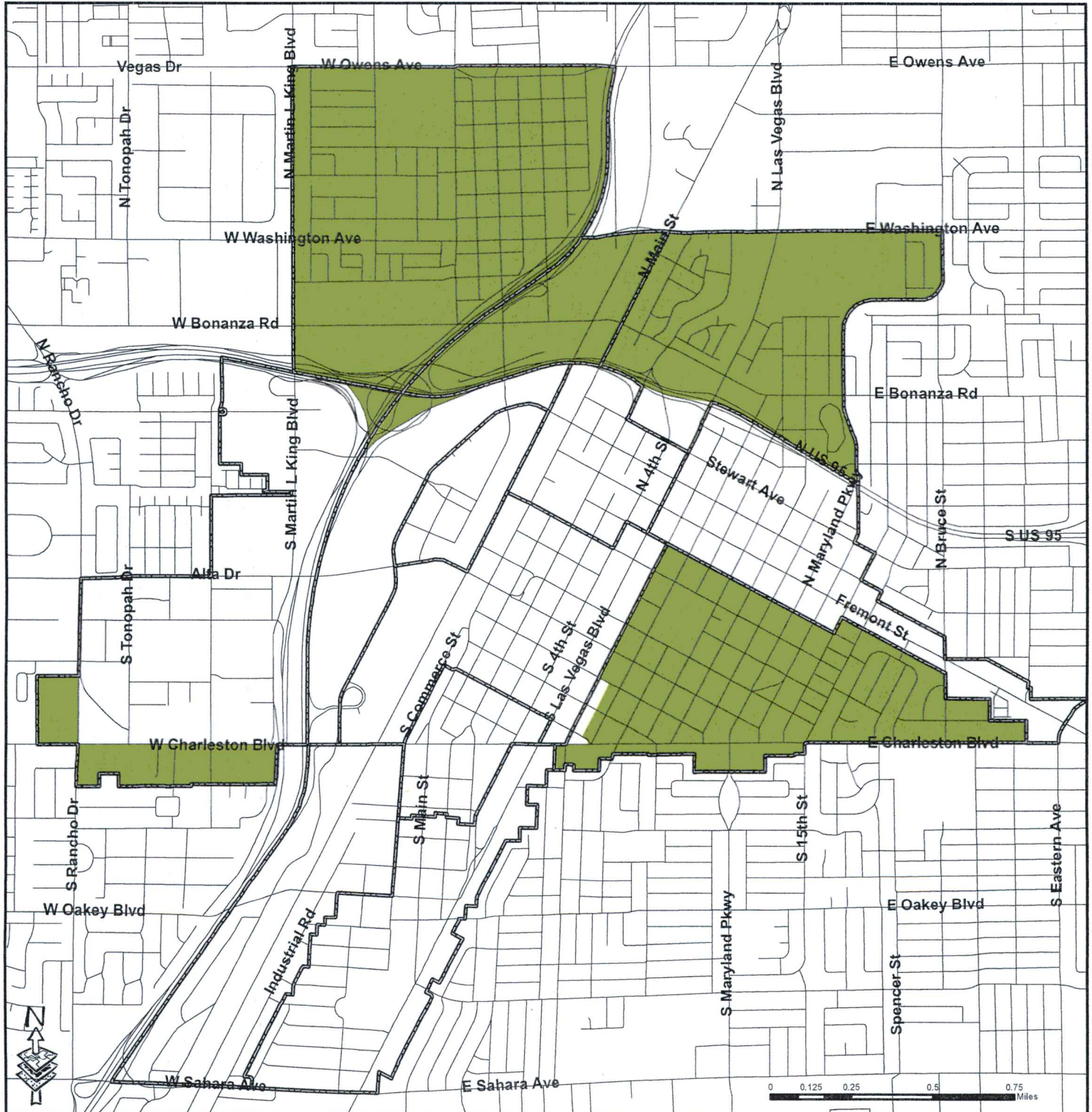


DTLV-O Area 2

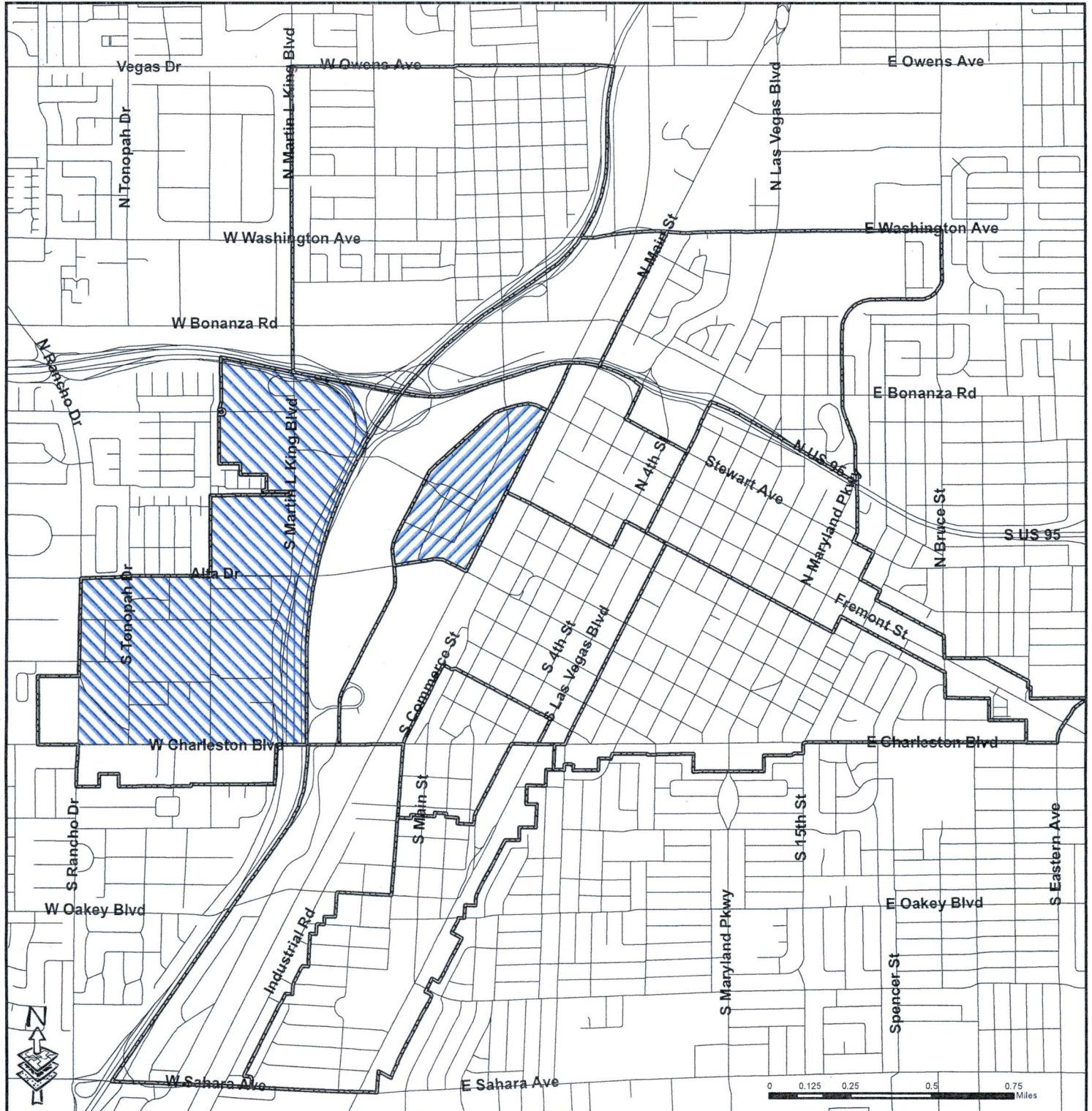


DTLV-O Area 3

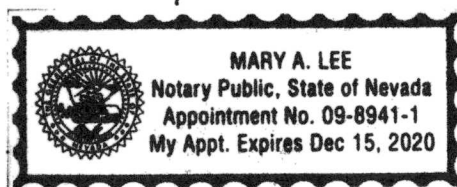
