THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 1, Chapter 16, Section 50, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

1.16.050: Ward No. 4 shall consist of that area of the City which is encompassed within election precinct numbers 2037, 2695, 2696, 2705, 2709, 2710, 2711, 3036, 3037, 3040, 3217, 3383, 3392, 3393, 3395, 3413, 3414, 3416, 3417, 3418, 3430, 3431, 3435, 3464, 3465, 3586, 3701, 3702, 3704, 3714, 3716, 3717, 3719, 3720, 3723, 3724, 3726, 3727, 3728, 3732, 3733, 3745, 3747, 3748, 3749, 3754, 3759, 3760, 3766, 3768, 3769, 3771, 3780, 3786, 3787, 3788, 3789, 3790 and 3807.

SECTION 2: Title 1, Chapter 16, Section 70, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

1.16.070: Ward No. 6 shall consist of that area of the City which is encompassed within election precinct numbers 2352, 2353, 2354, 2600, 2603, 2604, 2605, 2608, 2611, 2613, 2614, 2615, 2621, 2622, 2624, 2633, 2634, 2635, 2640, 2641, 2643, 2646, 2650, 2651, 2652, 2654, 2655, 2660, 2661, 2662, 2663, 2664, 2671, 2672, 2674, 2682, 2692, 2700, 2701, 2702, 2706, 2927, 2948, 3540 (those portions of the precinct located within the boundaries of the City), 3545, 3546, 3547, 3566, 3574, 3583, 3602, 3604, 3606, 3607, 3610, 3613, 3700, 3705, 3706, 3707, 3708, 3709, 3729, 3730, 3906, 3938 (those portions of the precinct

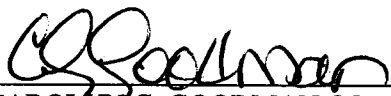

2 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
3 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
4 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
5 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
6 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
7 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
8 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

9 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
10 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983
11 Edition, in conflict herewith are hereby repealed.

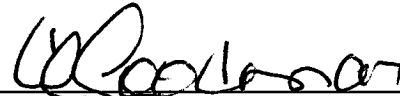

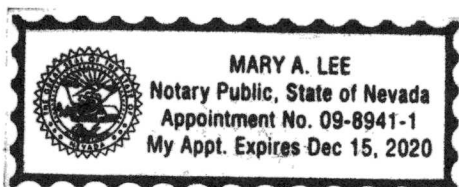
